



**Natural and Cultural Heritage Incentive Fund (NCHIF) – Preferred Contractors List Application Form**

The Natural and Cultural Heritage Incentive Fund is a method of encouraging Notable Tree owners to use arboriculture contractors with a sound understanding and experience with the technical and theoretical aspects of maintaining tree health. Trees which score highly (160 points and higher) on Council’s STEM assessment reports display high amenity, ecological, heritage and diversity functions which have public benefits that are experienced wider than the private property boundary (Note Council uses a modified STEM assessment methodology). This is why resource consents for minor maintenance of Notable Trees are free and simple to apply for, and tree owners who use preferred contractors are eligible for a reimbursement of tree works under the NCHIF.

Palmerston North’s stock of Notable Trees is under threat from subdivision, neglect, and poor arboriculture practices. The nature of adding Notable Trees via District Plan Changes means that often the rate of depletion in the stock of Notable Trees is higher than the rate of addition to the Notable Tree Schedule. This is why the health of these trees and the quality of arboriculture work is of utmost importance to Palmerston North’s stock of well-established trees.
