RECOMMENDATION(S) TO COUNCIL

1. That this report be received as information only.

1. ISSUE

In September 2017 St Marks and St Andrews Presbyterian Church made a submission to Council on the Long Term Plan. In short, there was an offer from the Parish Council to work with Council to determine a suitable future use for the St Marks site in line with their belief that the site, as a substantial piece of land centrally located in the Awapuni 'village', has potential to maintain its community service role.

2. UPDATE

In early March 2020 the Community Development Manager met with Annette Nixon and other members from the St Marks parish seeking an update on the original submission.

The key points from the conversation are:

- St Marks, St Andrews and St Davids have amalgamated into the 'Presbyterian New Church" with St Andrews being the new church. It will be strengthened and used as a worship and community space.
- St Davids will continue as is and no decision has been made about St Marks.
- The offer of the St Marks site for community service use still stands.
- No preferred ownership model has been identified but discussions could include leasing, buying or by joint agreement.
- It would be beneficial to form the paper walkway from the head of Panako Place through to Awapuni Park which would provide an easy linkage between the Community Centre, St Marks and the Awapuni shops etc.
- Of note is that the St Marks site has a large carpark opposite the Awapuni Shops and adjoins Council owned land.

3. NEXT STEPS

It will be helpful to consider the situation regarding St Marks Church within a wider discussion about community facilities for the City more generally. This is to ensure that any decision about a future relationship with St Marks takes into account all the relevant information and consequences for the Council and for the wider community.

Staff had intended to bring a report to the Community Development Committee regarding a city-wide research proposal to inform this wider discussion, but this has been delayed due to the COVID-19 Level 4 shut-down. It is not possible to progress the proposed research at this time. As an alternative, it is likely to be possible for this wider conversation to be had within the 10 Year Plan process. Staff envisage that the wider discussion will include consideration of community facilities throughout the city, alongside any proposals for new developments or future partnerships with other organisations.
