#### **RECOMMENDATION FOR PUBLIC RELEASE**

The decision can be released once negotiations with the third party are concluded.

### **RECOMMENDATION(S) TO COUNCIL**

1. That the Council approve an additional \$6,000 for 2021/22 to the Governance consultancy budget to provide advice and assistance to the Chief Executive's Performance Review Panel.

#### 1. ISSUE

Following the current review process the Panel has reviewed the assistance it receives and has sought an alternative consultant. The cost of the preferred consultant's process is an additional \$6,000 above the current budget allocation.

#### 2. BACKGROUND

The Council in its role of employer of the Chief Executive is required to conduct a yearly review of the Chief Executive's performance. During the process this year it was decided to seek proposals from three chosen providers to assist the Panel.
