RECOMMENDATION FOR PUBLIC RELEASE

The report and decisions, as outlined below, can be released from Part II after applicants and relevant Boards have been advised of the outcome.

RECOMMENDATION(S) TO COUNCIL

- That the decisions relating to the report titled 'Trustee/Director Appointments to Council Organisations' presented to Council on I September 2021, be released from Part II following notification of appointments to trustees/directors and Boards.
- 2. That Council appoint Ms Caroline Tate and Mr Evan Greensides to the Te Manawa Museums Trust Board for a period of up to three years.
- 3. That Council appoint Mr David Lea and Mr Neil Ulrich to the Regent Theatre Trust Board for a period of up to three years.
- 4. That Council appoint Mr Murray Georgel and Ms Sarah Laurence to the Board of Palmerston North Airport Limited for a period of up to three years.

1. ISSUE

An appointment process has been undertaken to seek candidates for the Regent Theatre Trust Board, Globe Theatre Trust Board, Te Manawa Museums Trust Board and the Board of Palmerston North Airport Limited (PNAL) as a result of retirement by rotation of board members.



The selection of the preferred candidates was undertaken following the completion of the appointment process in accordance with the Council's Policy. The interview panel comprised of the Mayor (Grant C Smith), Councillor Susan Baty, Councillor Rachel Bowen and the Chief Executive (Heather Shotter).

The resumes of recommended applicants are attached as Appendices 1-3.

2. BACKGROUND

In June 2021 the Boards advised the Council of the pending retirements by rotation of their respective Board members. Council approved that an appointment process be undertaken for two positions on the Regent Theatre Trust Board, two positions on the Te Manawa Museums Trust Board, two positions on the Globe Theatre Trust Board and two positions on the Palmerston North Airport Limited Board, in accordance with the Council's Policy on Appointment of Directors and Trustees. An appointment process was undertaken and the Council received a number of applications for positions on the Boards.

The Council received the following number of applications for each organisation:

Regent Theatre Trust Board 3

Te Manawa Museums Trust Board 3

PNAL Board 7

One of the applications received for the Te Manawa Museums Trust Board was subsequently withdrawn.

No applications were received for the Globe Theatre Trust Board positions; these have been re-advertised.

Two applications for the Palmerston North Airport Limited Board observer intern position have been received and will be decided in conjunction with Board members.

3. NEXT STEPS

In the event the Council adopts the appointment recommendations set out above, the appointed or re-appointed member(s) and unsuccessful applicants will be advised of the outcome of their application. The Trust Boards will then be advised of the successful appointees and the appointments will be made public.

An appointment process will be undertaken for the Globe Theatre Trust Board positions once applications have closed.
