1. OVERVIEW

1.1 Civic Honour Awards are Council's mechanism for recognising outstanding voluntary service in the community.

2. BACKGROUND

- 2.1 Council has sought nominations from the community for individuals deserving of recognition through a Civic Honour Award for voluntary service. A Selection Panel has been appointed. Ten nominations were received and considered by the Selection Panel
- 2.2 After consideration of the nominations the Selection Panel has recommended that Council grant awards to Valerie Bolter, Paul Patel, Philip Pirie, and Brian Watt.
 - a. Valerie Bolter was nominated by Dr Tania Kopytko and Lynette Sheehan for her voluntary work with the Manawatu Theatre Society, PN Operatic Society, Over 50's Dance Project, Manawatu Fiesta Flamenca along with numerous independent community projects. Valerie's award is for Services to Performing Arts.
 - b. **Paul Patel** was nominated by the Central Districts Indian Association where he has served the local Indian community over the past 39 years. Paul's award is for Community Leadership and Advocacy, Services to Sport and Safety.
 - c. **Philip Pirie** was nominated by Manawatu Striders, Inc. Mr Pirie is a volunteer with the Manawatu Striders. He established, and is the Chair of, the Manawatu Events Equipment Trust (MEET) a position he has held for 19 years. Philip's award is for Safety in Sport and Civil Defence.
 - d. **Brian Watt** was nominated by Craig Hart and Jill Hart for over 50 years' service to Lions Clubs. He held the positions of President, District Governor, and Chairman of the Lloyd Morgan Lions Clubs Charitable Trust. Brian's award is for a Lifetime of Community Service.

3.1 The Award recipients will be contacted and steps will be taken to arrange a presentation ceremony and associated publicity.
