#### **RECOMMENDATION FOR PUBLIC RELEASE**

The report and decisions, as outlined below, can be released from Part II following notification of appointments to trustees and Boards.

#### **RECOMMENDATION(S) TO COUNCIL**

1. That the report titled 'Rotation of Trustees/Directors on Council Organisations' presented to Council on 7 July 2021, and decisions, be released from Part II following notification of appointments to trustees and Boards.

#### Te Manawa Museums Trust Board

2. That the Council reappoints trustee Ms Caroline Tate to the Te Manawa Museums Trust Board and commence an appointment process inviting persons to apply for one trustee position on the Te Manawa Museums Trust Board;

OR

That the Council commences an appointment process inviting persons to apply for two trustee positions on the Te Manawa Museums Trust Board.

3. That it be noted that the Annual General Meeting of the Te Manawa Museums Trust Board is to be held on 30 September 2021.

#### Regent Theatre Trust Board

4. That the Council reappoints trustees Mr David Lea and Ms Tania Kopytko to the Regent Theatre Trust Board;



OR

That the Council commences an appointment process inviting persons to apply for two trustee positions on the Regent Theatre Trust Board.

5. That it be noted that the Annual General Meeting of the Regent Theatre Trust is to be held on 15 September 2021.

#### Globe Theatre Trust Board

- 6. That the Council commences an appointment process inviting persons to apply for two trustee positions on the Globe Theatre Trust Board.
- 7. That it be noted that the Annual General Meeting of the Globe Theatre Trust is proposed to be held on 30 September 2021.

#### Palmerston North Airport Limited Board

8. That the Council reappoints director Mr Murray Georgel to the Palmerston North Airport Limited Board and commence an appointment process inviting persons to apply for one director position on the Palmerston North Airport Limited Board;

OR

That the Council commences an appointment process inviting persons to apply for two director positions on the Palmerston North Airport Limited Board.

9. That it be noted that the Annual General Meeting of the Palmerston North Airport Limited is proposed to be held by entry in the Minute Book on 15 October 2021.

#### Caccia Birch Trust Board

10. That the Council extends the term of the current trustees on the Caccia Birch Trust Board until 1 August 2022.

#### 1. ISSUE

- 1.1 To inform the Council of the retirement/resignation of trustees/directors from the following respective Council Controlled Organisations (CCOs): Te Manawa Museums Trust – Ms Sarah Bell Globe Theatre Trust – Mrs Maxine Dale and Mr Gerard Hudson Palmerston North Airport Limited – Mr Jon Nichols
- 1.2 And the retirement by rotation of: Te Manawa Museums Trust – Ms Caroline Tate Regent Theatre Trust – Mr David Lea and Ms Tania Kopytko Palmerston North Airport Limited – Mr Murray Georgel
- **1.3** The Trust Deeds of the respective Trusts require annual rotation of a third of the Council-appointed trustees.



- 1.4 The Appointment of Directors and Trustees Policy states that all vacancies will be advertised unless there are exceptional circumstances as accepted by Council. It also states that those who retire by rotation and make themselves available for reappointment may be reappointed for a further term of up to three years.
- **1.5** If the Council decides to advertise all positions, we have the following number of vacancies:

Te Manawa Museums Trust – two positions Regent Theatre Trust – two positions Globe Theatre Trust – two positions Palmerston North Airport Limited – two positions

**1.6** On 2 June 2021, the Council resolved to bring the management of Caccia Birch House and gardens inhouse by 30 June 2022.

#### 2. BACKGROUND

- 2.1 Letters from Te Manawa Museums Trust Board, Regent Theatre Trust Board, Globe Theatre Trust Board and Palmerston North Airport Limited have been received by Council advising that their respective Board Members are due to retire by rotation, and outlining the retiring members availability for reappointment (if any) (see attachments).
- 2.2 Officers recommend, in the case of the Regent Theatre Trust Board, that the Council take the request of the Trust Board into account and reappoint David Lea and Tania Kopytko to maintain stability of governance as the theatre recovers from the impact of COVID-19 and the change of General Manager.
- 2.3 Officers recommend, in the case of the Caccia Birch Trust Board, that the Council extend the term of the current trustees until 1 August 2022 to maintain stability of governance over the transition period.
- 2.4 Council-controlled Organisations are requested to advise the Council as soon as possible, but not later than three months prior to the date of expiry of a trustee's or director's term. Such advice should include the details of the trustees/directors who are due to retire and whether or not they wish to be considered for reappointment. The Council is entitled to appoint up to five members on the Te Manawa Museums Trust Board, six members on the Regent Theatre Trust Board, five members on the Globe Theatre Trust Board and five members on the Palmerston North Airport Limited Board.
- 2.5 In appointing directors/trustees, the Council will be seeking persons with relevant skills and ability to make a significant contribution to the successful operation of the organisation concerned.



#### 3. NEXT STEPS

- **3.1** Respective Boards will be informed of reappointments and/or new appointments.
- **3.2** If the Council decides to advertise the positions, an appointment process will be set out as per the Appointment of Directors and Trustees Policy. The Appointment Panel will comprise of:
  - The Mayor and/or Deputy Mayor
  - Chair of the Finance & Audit Committee
  - Chair of the Arts, Culture & Heritage Committee
  - The Chief Executive (or their representative)

#### **RE: Te Manawa Trust Board Rotation of Trustees**

In accordance with the requirements of the Trust Deed, I advise that Sarah Bell is due to retire as a Trustee of the Te Manawa Trust Board in August 2021. Sarah has been a valued member of the Board; however, she has chosen not to request reappointment. Accordingly, her Trustee position will need to be advertised and an appointment made by Palmerston North City Council.

We are also required to offer up another Trustee for retirement. Caroline Tate has offered to be considered by PNCC. She has indicated a strong desire to be reappointed for a further term. The Trust Board has a succession plan in place due to my retirement next year as Chair. Caroline is currently Deputy Chair and has been endorsed by the Board to take on the role of Chair from my retirement. I strongly endorse this and so I would recommend that her term is extended for a further 3 years, to enable continuity for the Board and allow for a seamless transition to this next phase.

#### The AGM for Te Manawa will be held on 30 September 2021.

RETIREMENT BY ROTATION & ANNUAL GENERAL MEETING REGENT THEATRE TRUST BOARD

The Regent Theatre Trust Board will be holding its Annual General Meeting on Wednesday 15 September 2021, at which time two members of the Board are required to retire by rotation.

Mr David Lea was reappointed and Ms Tania Kopytko was appointed to the Board in August 2018. Due to the Trust Deed stating that at each AGM of the Board, at least one third of the Ordinary Trustees shall retire from the position of Trustee, and as they are the longest serving Trustees since their previous reappointments, they are due to retire by rotation in August 2021.

The Board ask that Council consider re-appointing both Trustees as allowed for under clause 9.2 of the Appointment of Directors and Trustees Policy. The Regent Theatre continues to recover from the impact of COVID-19 and the resignation in March 2021 of the General Manager, Kathiy Watson. It is vital there is stability at a governance level to manage the challenges ahead and hence the request to re-appoint both Trustees who have indicated they wish to remain on the Board.
