

MAY IT PLEASE THE HEARINGS PANEL

- [1] This Memorandum is to accompany the Planning Report and technical reports filed by the reporting officers engaged by the Council in accordance with s 42A of the Resource Management Act 1991, in respect of KiwiRail's Notice of Requirement ("NoR") to deliver a new Regional Freight Hub ("Freight Hub").
- [2] The reporting officers have prepared twelve reports on various expert topics relevant to the Panel's consideration of the NoR, and to aid the Panel in making recommendations to the requiring authority under s 171 of the RMA. The expert report topics cover various environmental issues identified by the Council's reporting team in KiwiRail's NoR (including the plans, assessment of environmental effects, multi-criteria analysis report, and technical assessment reports), s 92 responses, and submissions on the NoR.
- [3] The reports that have been prepared, and which will be available on the Council's website, are:
 - (a) Section 42A Technical Officers' Planning Report by Anita Copplestone and Phillip Percy;
 - (b) Technical Report on Traffic and Transport effects by Harriet Fraser;
 - (c) Technical Report on Noise and Vibration effects by Nigel Lloyd;
 - (d) Technical Report on Landscape and visual effects by Chantal Whitby;
 - (e) Technical Report on ecological effects by Justine Quinn;
 - (f) Technical Report on Stormwater and Flooding by David Arseneau and Reiko Baugham;
 - (g) Technical Report on Lighting effects by Glen Wright;
 - (h) Technical Report on Air quality effects by Deborah Ryan;
 - (i) Technical Report on Social effects by Amelia Linzey;

- (j) Technical Report on Economic effects by Shane Vuletich;
- (k) Technical Report on Palmerston North City Council Assets and Infrastructure by Robert van Bentum; and
- (I) Technical Report on Railway track design, construction and operation by Michael Than.
- [4] Commensurate with the significance of the Freight Hub proposal, the reporting officers have thoroughly assessed the NoR and its effects, and this has resulted in extensive reports and recommendations. The reporting officers are aware of the time investments that will be required for participants to traverse these reports and understand their content. To help with this undertaking, the reporting officers have all prepared 'executive summaries' of their opinions, which can be found at the beginning of each report.
- [5] The Planning Report is a particularly comprehensive document, containing many conclusions and recommendations that draw from all information available in respect of the NoR. Ms Copplestone and Mr Percy considered that it would be helpful to prepare a 'companion document' to the Planning Report. This companion document includes a summary of the effects of the NoR and the authors' recommendations in relation to those effects, including as to conditions on the designation. The report: "s 42A Planning Report Companion document Table of Effects and Recommendations", is available on the Council's website for this project.
- [6] Finally, a table including all relevant planning provisions is being finalised, and will also be made available on the Council's website for all participants.
