INFORMATION AND CONDITIONS RELATING TO A WATER FILLING STATION PERMIT

The use of a tanker filling station is controlled by the Palmerston North Water Supply Bylaw 2015.

The facility can provide water up to 25 m³/hr. The current charge rate is available at www.pncc.govt.nz.

CONDITIONS

1. EQUIPMENT

1.1. The applicant is responsible for providing all the equipment necessary to connect to the filling station.

2. RESPONSIBILITY FOR DAMAGE

- 2.1. It is the applicant's responsibility not to disclose the unique access code to any unrelated parties, to avoid other people drawing water using their account.
- 2.2. The applicant is required to inform the Council Officer of any possible defect or damage to the Filling Station.
- 2.3. The applicant will be held responsible for the cost of any repairs of damage caused by the incorrect operation of a tanker filling station.
- 2.4. The applicant will also be held responsible for any third party damage that occurs whilst the tanker filling station is in use.
- 2.5. In this regard (for example), the operator must wear an orange high visibility vest and use at least 3 x 900 mm orange double reflector cones to warn vehicles and pedestrians of the obstruction or danger.

3. PAYMENT OF FEES

3.1. The applicant must ensure that all applicable fees are paid on time for this filling station. Service may be discontinued if fees are unpaid.

4. DECLARATION


4.1. A false declaration or other action, which results in a significant expense or inconvenience to Council, will result in immediate cancellation of the Permit and may result in prosecution.

5. CANCELLATION

5.1. The Council reserves the right to cancel any permit at any date or time by giving notice to the station operator.
