Hi Eamon,

I apologise for the delayed response.

Regarding the advice note, we recommend using the term "will" instead of "may" to better emphasises the OnePlan requirement under LF-AWBD-R68. Enforceability should not be an issue, as the note simply directs the applicant to HRC, highlighting the requirement.

Any excavation or earthworks (including planting of trees and shrubs) or structures (including some fences) on or within 8m of the inland toe of the stopbank or any other structure that is maintained by Manawatū-Whanganui Regional Council for the purposes of flood control may will require consent from Manawatū-Whanganui Regional Council. Plan users are advised to consult with the Manawatū-Whanganui Regional Council for any works on or within 8m of the inland toe of the stopbank.

In terms of the structure plan, we prefer option 2. We recommend replacing the term "approximate" with "indicative", and "may" with "will". We also noted that option 1 reflects current structure plan in the proposed PC E, while option 2 incorporates the changes we previously requested.

Lastly, we would like to confirm that no major work are currently scheduled for the stopbank, aside from general maintenance.

Good Afternoon Aruna and Leana,

Thanks for meeting with us last week to discuss Horizons submission in relation to the Roxburgh Plan Change.

As discussed I have attached an updated agenda document with included discussion points & actions, post meeting. Could you please confirm if these meeting discussion & action notes are correct or if amendments are required?

Otherwise feel free to make comments in the document as to where changes are needed.

In additions below are responses to various action points raised in the meeting.

- 1. Contaminated Soil and LIMs Council's GIS maps have identified all sites in the DSI, which are subject to contaminated soil. I can confirm that the contaminated sites in RRA will be captured in future LIMs.
- 2. The revised advice note wording under Rule 10.6.1.8 is below to include Horizons earthworks and works in proximity to the stopbank is below:
 - a. Any excavation or earthworks (including planting of trees and shrubs) or structures (including some fences) on or within 8m of the inland toe of the stopbank or any other structure that is maintained by Manawatū-Whanganui Regional Council for the purposes of flood control may require consent from Manawatū-Whanganui Regional Council. Plan users are advised to consult with the Manawatū-Whanganui Regional Council for any works on or within 8m of the inland toe of the stopbank."
 - b. Any earthworks may require resource consent from Manawatu Wanganui Regional Council. Plan users are advised to contact Manawatu Wanganui Regional Council for further information.

I should note that Advice Notes/Note to Plan Users are not legally enforceable therefore we have to use wording such as 'may' instead of 'must'.

3. We have amended the structure plan to outline that works within 8m of the inland toe of the stopbank may require resource consent. However two options have been drafted, can you please review them and provide feedback? If there a preferred option please let me know.

I have not heard from Aaron Phillips – Activities Manager for Parks regarding Council's process for checking if works near stop bank require resource consent. I will follow up next week.


