I would like to express my firm concern regarding the recent proposal to change regulations at Linklater Dog Park, specifically the introduction of on-leash zones in what was previously an off-leash park.

As you are aware, the overwhelming majority of the submissions during the last consultation overwhelmingly supported the park being left as off-leash. Given this, the recent decision to impose on-leash restrictions on half of the park, including the paddock containing the dog agility equipment, is not only surprising but deeply disappointing. It is contrary to the expressed wishes of the majority of the community and seems to ignore the fact that the vast majority of dog owners who use this park do so with the expectation of a safe, enjoyable space for their dogs to exercise freely.

It is important to note that Linklater Dog Park is one of the few off-leash spaces in the city, and it serves as a vital community hub for dog owners. For many, it is not just a place to walk a dog; it is a space for dogs to socialize, exercise, and interact in an environment that promotes their well-being. The decision to restrict so much of the park to on-leash only, including the agility area, is contrary to the intended purpose of this park and is in direct conflict with the needs and desires of the community.

Furthermore, it is unrealistic and impractical to assume that dog owners should be restricted in such a large portion of the park. In fact, it's rare to see anyone in the park without a dog, and the lack of off-leash space in the Palmerston North area is already a growing concern among the community. The introduction of extensive on-leash areas may also discourage responsible dog ownership, as many dog owners prefer spaces where their dogs can interact and run freely without constant restrictions.

Please write down any other feedback you would like to share with us about our proposal.

I am happy to accept certain areas of the park being designated onleash for the safety and consideration of others, such as the designated play zones. However, the continued availability of a large, off-leash area is crucial for both the well-being of the dogs and the enjoyment of the community. Reducing off-leash space by such a drastic measure is both unnecessary and unfair to the overwhelming majority of dog owners who use the park regularly and responsibly.

I urge the Council to reconsider this proposal and restore the off-leash areas, with the exception of the play areas. The community has spoken, and the clear majority want to maintain Linklater Dog Park as a space where dogs can run, play, and interact freely. It is essential that this park remains a place that serves the needs of responsible dog owners and their pets.

I sincerely hope that you will prioritize the interests and well-being of our community of dog owners.

- 2. No off lead access to the water hole under the bridge for dogs to swim!
- 3. The cost of erecting a fence in the position indicated will be considerable. A large cost for the small gain of a small group of locals who rarely attend the park. Better to re-zone at the existing farm wire fence that already exists beside the bike track.
- 4. Today, Fri 27 June we walked frm 8:15 to 10:00. There were about 20+ people walking about 25+ dogs. Tomorrow and Sunday there will be 30+ people and dogs...continually. Will the moaning minority even be there...I bet not.
- 5. The playground is underutilised. Only in summer and on pleasant weekends do we see maybe 3-4 people with kiddies. The sign says no dogs within 30 metres..really? So the path is only about 5-10 metres from this area. So is the dog water station! Rules posted that can't possibly be obeyed.

We walk here 5 days a week. Have so for 2-3 years. Have not witnessed any dog "attack" on a person. We have seen several incidents where dogs trot up to people and poke their noses looking for treats..or make an attempt to jump up in a friendly way and some of these people have panicked, shouted and become angry and hostile to the dog owner. This is the worst I have seen. Why walk in a dog park and then complain when dogs act in a playful way. Most dog owners will call their dog back and restain them in these situations. But panicky, nervous people can't deal with it...and frankly are walking in the wrong place. Why put yourselves in an environment you will not be comfortable in? I think some of these people are looking for conflict in order to stake their claim tothe park. Have never seen ever a dog actually ATTACK a person. I have been attacked twice in my life by dogs. Both times I was on a PN footpath and both times the approaching dog was on a lead. A dog on a lead if scared or spooked will feel very threatened and will launch at an approaching "threat"..in my cases - I was a runner. At Linklater - I have seen 2 incidents where dogs restrained on a lead have gotten into a handbag scrap with an another dog - because of this feeling of vulnerability.

What made you want to give feedback on this consultation?

You invited it on your notice and I feel quite angryy that PNCC is making a too significant intrusion into the offlead area in order to satisfy a small number of complaining peope who are not compatible with dogs. The absolute waste of PNCC ratepayers money on this drama. You have not gone for a sensible compromise. A 50/50 split is a soft way out of the drama. This park has been designated as a dog off lead area for too many years now. I believe (based on newspaper article) that a huge majority are in NOT in favour of this - yet you persist in a non-democratic fashion.

Linklater, however, is an explicitly dog-friendly park where members of the public know they will encounter dogs no matter what. There are lots of other parks and recreational spaces in Palmerston for people to go if they do not want to encounter dogs off leash, or even at all. Restricting the off-leash space so much may also prevent dogs with less mobile owners from getting to be off leash at all, for the most common carpark is at the front, and walking to the back just to let the dog loose may be too strenuous for those with disabilities, illnesses, or older dogs. 1 My view is that there are many parks and children's play areas in Palmy where dogs have to be on the lead but only one which is completely off lead. Linklater is a fabulous asset for Palmy and something we should boast on rather than water down. For those who do not like the off lead experience they have all the other places they can go.

2 Have there been any examples of off lead dogs in Linklater Park doing significant harm and if so could you please share them so we might perhaps understand that there is rational planning rather than emotive posturing behind this plan? 'Palmy is a paradise for dog walkers. We've got loads of great spaces where you can let your four-legged family member run around to their heart's content. We call these dog exercise areas. Remember, you need to exercise your dog on a lead unless they're in a designated dog exercise area.' PNCC website.

I agree with the above statement - there are many places and a variety of environments for dog-owners to find the best for their pooch, and so it is surprising that we are going through this consultation exercise again! Given the amount of feedback in the last Linklater Reserve Dog-Lead Consultation that the Strategy and Finance Committee received, I find it incredible that we have to do this again - surely there was enough information in the last to put this issue to bed!

I am against this change in policy for several reasons:

The previous feedback that PNCC received on this matter, barley six-months ago, was overwhelmingly in favour of keeping the status quo for Linklater, with a huge majority of people asking for the current policy to remain.

Although I feel for the people who have experienced some difficulties with other dogs, as a regular user of this space I must say this is not what we all experience. The small number of people asking council to consider this proposal is not a reason for change. Kelvin Grove Community Centre Group does not represent me, and in my time using Linklater Reserve I have never had an aggressive experience. Sometimes people feel a sense of worry when none exists. The anecdotal evidences and experiences given to council are extreme, and felt by people who would feel vulnerable in many places.

In the Kelvin Grove area there are around 1200 registered dogs. In Palmerston North as a whole there are only two fenced off-leash dog exercise areas. Linklater is the only one of a large size, with variable tracks and a variety of terrain. This offers most of Palmerston North's population with a variety of options for a whole family. In our area, and for most of Palmerston North, this is the only large, variable place to take our dog off-lead for important exercise & socialisation. Other off-lead areas in the city are either not fenced, or do not offer the space or variety that Linklater Reserve does.

In our city there are 510 kilometres of footpaths for on-leash walking anywhere in the city. There are around 73 hectares of parks and reserves in our city, spread across the city (PNCC website). Included in this, there are around 10 hectares of reserves in Kelvin Grove suburb itself. If people want an on-lead experience then there is a massive amount of space in which to do this safely and enjoyably in other places. There is plenty of reserve space to be shared, but it does not always have to be in one place.

'You can't exercise your dog in any prohibited places. This includes within 30 metres of a playground, and all sportsfields and cemeteries.' (PNCC website) There are rules and by-laws to deal with any dog-related issues, and plenty of ways in which those worried for their well-being or dog can access hep to see these owners 'corrected'. PNCC is a big part of that issue in terms of enforcement.

This policy change is not going to take away the highlighted issues

people are asking PNCC to address through this policy proposal. If a dog is aggressive, or if people bring their dog close to a playground there are bylaws are in place to deal with this.

There are plenty of spaces for family experiences where on-lead is expected. reserves, playgrounds, parks. Linklater is the only place in our area that provides for off-lead lovers.

For the reasons above, we do not have to change the current Linklater policy at all. It's a 'NO' from me.

I have been using Linklater Reserve almost daily for the past six years with my two dogs, and I strongly oppose this proposal.

This change feels like an overreaction that penalises the overwhelming majority of responsible dog owners because of the behaviour of a small minority. Before any decision is made, the Council should publish the actual evidence behind this proposal. Specifically:

How many complaints or incidents have there been?

Over what time period?

How many involved serious aggression or injury versus minor issues?

Were the incidents concentrated in particular areas or times?

Without clear, transparent data, it's difficult to see how halving the offleash space is justified.

Linklater Reserve is unique in Palmerston North. It is the only large, fully fenced park dedicated to off-leash exercise and dog socialisation. There are already plenty of on-leash or dog-prohibited parks across the city, including:

The Esplanade

Memorial Park

Victoria Esplanade Gardens

Monrad Park

Hokowhitu Lagoon area

Many neighbourhood playgrounds and reserves

If people prefer to avoid dogs, they have numerous alternatives. Dog owners, on the other hand, have almost no other options for safe, purpose-built off-leash exercise.

It is also completely contradictory to require dogs to be on a lead around the dog exercise equipment. This area was designed precisely to allow dogs to move freely and use agility structures safely. Putting dogs on a leash in that zone undermines the purpose of having a dog park in the first place.

Reducing the off-leash area by half will likely create overcrowding and more tension between dogs, not less. It will also make it much harder for owners to meet their dogs' physical and mental exercise needs.

Instead of imposing sweeping restrictions, I urge the Council to:

Focus on targeted enforcement against genuinely irresponsible owners and aggressive dogs

Improve signage about expected behaviour

Educate users about safe dog handling and recall

Consider time-based restrictions in specific areas, rather than permanent blanket rules

This proposal is neither balanced nor fair. It removes a vital community asset from responsible owners who have used it safely for years. I ask the Council to reconsider this decision and engage openly with the full community of park users before taking such drastic measures.

It is the most ridiculous change I've ever heard and a waste of rate payer money to install a fence and a gate along half the park. I understand the playground area at the bottom being on lead but beyond that is ridiculous. The dog agility part is within the leashed area so that would need to be moved, costing even more money. Linklater is the only fully fenced large off lead area in Palmerston North and if people have an issue with off lead dogs then they can go to one of the other many parks and walkways where they are required to be on lead. We are moving towards high density housing where people do not have suitable backyards for their dogs to run around in so parks that allow at least 3km of walkway offlead are beneficial for wellbeing, social, and behavioural requirements of dogs. I understand there have been issues with some dogs but I go there multiple times a week and have been for years and have seen very few out of control dogs. Mostly puppies who are learning. Everyone else is very respectful. Do not take away the one place we have for safe off lead walks. We have no other options. Dogs are part of our families and we need a large place where we can allow them to run free and sniff at their leisure.

Because I feel so strongly that Linklater should be kept off leash as it is the only place in Palmerston North that is fully fenced and safe with no pest control traps or fast running rivers where dogs could drown etc like in other off lead walks. It is also very open making it easier to see and control your dog as opposed to bush walk where if your dogs runs it can be harder to see them making it more unsafe to both the dog and those around them.

There is an amazing community of dog owners at Linklater who also enjoy walking together and stopping to chat while socialising their dogs. The majority of the people there have amazing control over their dogs and do the right thing. When we see on lead dogs we make sure our dogs are by our side or put on a lead. How about you actually listen when I call up for roaming aggressive dogs and follow up with their owners rather than driving past and saying oh I can't see them out despite me and my husband making multiple complaints and providing the address of the concerned dogs.
