What's worrying is that this proposal goes against the feedback council already received. Most people clearly said they want Linklater to remain fully off leash. It's disheartening to see that being overlooked. Public consultation only works if the input is genuinely taken into account. Splitting the park into leash and no-leash zones adds confusion, misunderstandings between people, uncertainty about the rules, and uneven enforcement. A simpler, consistent approach makes for a better experience all round. Those who prefer or need leash-only spaces already have plenty of options throughout the city, on the streets, walkways, and almost all of the other local parks. Off-leash areas are rare, and reducing the size of this one would take away something valuable that many of us rely on. I ask council to please reconsider. Linklater works well as a fully offleash park. It's well used, well loved, and contributes positively to people's lives. Let's keep it that way. What made you want to give feedback on this consultation? I chose to give feedback because Linklater Reserve plays a meaningful role in my daily life and in the lives of many others in the community. Thank you for the opportunity to submit on the proposed changes to Linklater Reserve.

Linklater Reserve is one of the few places in the area where people can walk their dogs off leash. It is the only off-leash reserve where dogs have a large area to run, play and socialise with other dogs and people. As any responsible dog owner knows socialisation is one of the most important things you can teach your dog. Having a dog on a leash increases anxiety for some dogs and can cause issues with unnecessary aggression.

Linklater is also a great place for owners to learn about natural dog behaviour. A lot of new owners become anxious when their dog is approached and this anxiety is projected to their dog which can cause issues. I have seen people overreact when young dogs are 'told off' by older dogs as part of the socialisation process, people initially think that dogs growling is aggression but it is just dogs way of communicating and teaching young dogs how to behave. It doesn't take long before the new owners begin to understand what socialisation involves.

I understand that some people do not like dogs and do not want to be approached by dogs. A Google search has indicated there are around 170 parks, reserves and walks in the PNCC area, more than enough for these people to enjoy the reserves and the outdoors without dogs. So I do not understand why you are considering reducing this area and effectively only having a small area where dogs are able to 'be dogs', get great exercise and improve social skills.

The proposed on-leash area includes the dog agility course which does not make sense. It also includes the area where the stream runs through the reserve which is a very popular area for dogs to cool down especially during the summer months.

If necessary I would support the playground area being fenced to not allow dogs.

Ahimate Reserve is another off-leash area, but the compound is quite small and restrictive if there are a lot of dogs there. I have seen more issues of aggression there than at Linklater due to the confined space. I am concerned that, with the amount of people who walk their dogs at Linklater Reserve, if the size of the reserve is decreased there will be too many dogs in a small area. This will not allow for dogs to isolate themselves if they feel overwhelmed with the numbers of dogs which they can do now.

I regularly walk at Linklater with a group in the weekends, we can have as many as 12 dogs in the group without incident plus the dogs we come across. I have seen several young dogs at the reserve who learn social skill from older dogs, this socialisation does not happen when dogs are on a leash.

I regularly meet people who are staying locally or come from nearby towns to walk their dogs at Linklater Reserve and all say what a wonderful and unique area it is for dogs. I come from Ashhurst to walk my dog there when I am not walking at the Ashhurst Domain my dog prefers Linklater, he gets very excited when going there as he is always meeting new dogs.

It is the only place where dogs are allowed to be dogs. Please do not take this reserve away from responsible dog owners. It is a great facility. I am happy to be contacted if you wish to discuss this or have any queries or concerns.

I walk my dog every day and am a responsible dog owner. I feel if Linklater is removed it will restrict where dog owners can responsibly walk their dogs off lead which I think is very important for socialisation of dogs.

There is nowhere else in Palmy where dogs can be off-leash and completely safe from vehicle, bike, and e-bike traffic (except for the very small dog park in Ahimate Reserve). Recent instances around the Pitama Road area support this, the latest post was of both dogs being on leads and still managing to attack each other. Councillor Findlay hit it on the head, the small minority of bad dog owners spoil it for the good dog owners

I 100 % agree that the area around the children's play ground, toilets, flying fox, bike track, could easily be fenced off into a total non dog area, with the exception of owners needing to use the toilet facility, in which case they could put their dog on a lead for this purpose. Then the residual area could be a fully off lease area. (This is not the only park in the area as councillors where lead to believe, there are several limed walking areas in the vicinity, including James line and the newly established Tamakuku Terrace. Fern lea park is also a great local family park) Fencing off the front area (off Kelvin Grove Road) entry would mean you wouldn't get the irresponsible owners not picking up after their dogs, or scenting on the stools and bbq, a much cleaner, hygienic option for family orientated activities. The double gates on Kelvin Grove Road end could be turned into a walk way that follows the wetland area around leading up to the back of the park. Following the fence line around the wet land area's, would /could reduce health and safety issues for parents who don't always keep an eye on their children in and around the numerous waterways that exist on the park. The submitters from the Kelvin Grove Community at the Strategy and Finance committee meeting on the 28 May 2025 complained that they had lost the ability to be able to use the park to do their minimum 30 minutes of exercise a day.

The primary issue with Linklater has been people not having control of their dogs and due to this lack of control these dogs inadvertently invade the space and safety of the owners whose dogs who are on leash. Dogs on leash are under control and unable to run over to other dogs or people. Off leash dogs often have poor recall or no recall at all. This is due to the park being an excitable place which increases arousal in dogs causing them to struggle to follow cues from their owners especially a recall cue. This leads to dogs on lead being rushed, there may be smaller dogs rushed by larger dogs or older dogs rushed by younger dogs. The dogs on leash are unable to move away to feel a sense of safey due to being on the lead. Often the off leash dog might jump on the on leash dog or be pushy until the off leash dog owner can retrieve their down which can take some time. In this time trying to retrieve the off leash dog conflict between owners arises and stress, frustration or anxiety for the dogs on leash develops. My main concern is that these same owners who want to have their dogs off leash may not respect the designated area of the park fully or may start to let their dog off before the designated area as they see others do it. In both scenarios there is nothing stopping these owners from letting their dog off "incorrectly" given the rules of the park. Having on leash as a blanket rule will result in less blurred lines on when people let their dog off as they will know the whole park is on leash. A person who wants to give their dog more freedom on walks and the ability to move further from them can learn to effectively use a long line. On leash parks protect all dogs and allow dogs and owners to respect each other by reducing conflict. Dogs on leash have little option when confronted by bulshy, confident off leash dogs who may want to play but for the on leash dog can be a traumatic experience.

I have been a Dog Trainer in the Manawatu for over 10 years. I work with puppies and adults and specialize in anxiety, aggression and frustration. I have had many clients seek my help to rehabilitate their dogs who have specifically had traumatic experiences at Linklater park. One was a small puppy who was on leash and got rushed by 3 off leash large dogs. As a certified professional dog trainer I know people miss key body language cues from dogs and this results in problems. Linklater being off leash creates more opportunities for dogs who have not had training to fail to communicate because they have not learnt what is polite and what is not in doggy language. This means the on leash dogs to fail too because they are stuck for options and go into fight or flight. Our dogs dont need to be off leash to have fun and be socialized. Socialization itself if just being around different sights, sounds, distractions but not necessarily interacting with other dogs. Dogs who are elderly or young are more vulnerable to having a poor experience if approached by off leash dogs because they are either sore, have health issues or building associations (puppies). The answer to having a carefree walk with no recall or control should not be to go to Linklater. Linklater should be a place all dogs and owners can feel comfortable and safe and be able to walk on a short or long leash. The experience dogs have at Linklater can change for the better for a huge amount of dogs if Linklater is kept on leash. Just like people not all dogs are overly social wanting to make friends with everyone, its selective.

As a Professional and dog owner i feel it is important to share the fallout i see from off leash encounters in my clients and own dog. Without understanding canine behaviour its easy to put human needs first. If this

park is for the dogs then it should respect all canines and their boundaries.

I have been living back in Palmy for 1.5 years and have not had an issue here. After walking 13 minutes from my house I do not always have the time or energy to walk my dog all the way to the back of the park to get off lead time, especially during my lunch break, I would end up having to drive down.

Specifically in the wetlands I only see dog owners, runners and frisbee golf people. I do not see the huge area with the dog agility to be utilised space if this becomes on lead.
