	I propose that if you are going to go ahead with fencing off any of the park, fence around the wetland and put a gate there with signs to put back on leash, fencing the flying fox in the playground zone and picnic area, leaving the agility area and wetlands open and off leash.
	Also, I believe there are numerous places in and around our city where people can go where dogs are not permitted - on or off leash. I think if people don't like dogs or are scared of dogs, avoiding off leash places seems a logical idea.



By my estimate, I would guess that upward of 80% of people visiting Linklater Reserve are dog owners and this would easily add up to several hundred dogs and their families on both a Saturday and Sunday. These people mainly come here for two reasons: to walk their dog off leash and to allow their dogs to play and socialise with other dogs. This is fun for the dogs and families and also great for the health and behaviour of our pets. Most people seem to walk their dog in a loop around the indicated yellow area. In order to now make use of the offleash area, dog walkers will have to double the length of the walk and this isn't easy for some people (elderly, young children), particularly noting that some areas of the off-leash area are quite steep. This will quite severely affect the ability for dog owners to give their pets the exercise, socialisation and the fun that they deserve. Additionally, all of the best attractions and features of the reserve are within the proposed on-leash area. The rest of the reserve is quite plain in comparison and it will lose much of its current appeal if altered

The proposal states that the majority of submission have been opposed to this course of action and so I struggle to see why the proposed option has been given as it seems to cater entirely to the small minority of people who are opposed and will ruin the experience for the majority of people who love the current setup. I've visited countless times and have never seen a dog act aggressively to a person in all that time and I suspect any stats on dog attacks at the park will reflect this. I don't think there are reasonable grounds to suggest that the current environment is unsafe for anyone.

Dog owners have only two dog parks to choose from in Palmy, and Linklater is clearly far better and more popular than Ahimate, which attracts substantially less dogs and people. People who aren't comfortable being in a shared space have many other options in Palmy and I believe there are about a half dozen parks/reserves within a kilometre of Linklater alone and all of the attractions of Linklater can be found in other parks around the city. Anyone raising an issue with the current setup is spoilt for choice and can easily experience what Linklater has to offer at many other great parks within the city.

I strongly believe the current setup should remain, but failing that, there are several other options that I think are far better and would work for all involved. Such as:

- Upgrade a nearby park such as the Kelvin Grove Park with facilities similar to Linklater.
- Fencing in a small area of the park to be on-leash or even dog-free e.g. the BBQs and playground only.
- Not allowing dangerous breeds of dogs to be off-leash at the park.
- Designated on-leash hours

While I support the idea of clearly and physically defining the off-leash dog area, I do not support the area proposed in the supplied diagram. The proposal ignores the most obvious natural and physical break that already exists and the investment already made by ratepayers in the dog agility area and other improvements. The line of trees and fencing just to the west of the bike pump track is the most obvious and financially prudent line to divide the park in terms of on-leash and off-leash areas. There is existing fencing (albeit in need of some repair) and trees, that form a natural barrier that, in comparison the proposed break, will be far cheaper for the council and consequently ratepayers, to create a defined divide between two primary use areas in the park. Also, the council, and ratepayers, have already upgraded the pathways and the dog agility area that the proposal will then be in the on-leash area. This will either make the agility area impractical and of no-value, or require the council to spend more money to relocate it to within the new on-leash area. Therefore, the proposal ignores the existing natural break and either the wastage of previous investments, and/or the need for further investments to move the dog agility area. The most obvious and financially prudent solution is to move the break for the two primary use areas to the line of trees and fencing just to the west of the bike pump track.

The rationale for the change should be far clearer than communicated. It is fair to assume that when the original park was designed and the areas designated that it was carefully considered. It is not clear what has since changed to make those original considerations invalid. Furthermore, there is no clear reasoning for the proposed break point between what will be the win-leash and off-leash areas. In fact, what is proposed appears completely counterintuitive and therefore should be even more clearly explained in the proposal. Those issues aside, there is a clearly an alternative to anyone who goes to the park and looks at the area and what is being proposed.

An obviously flawed and low-quality proposal with little to no justification and reasoning provided that will add unnecessary cost to ratepayers - when compared to the alternative I have suggested in my submission above.

Additionally, this approach would avoid the need to relocate the dog agility equipment and would only require the plane to be moved into the new on-leash zone if desired.
