There are great playgrounds for children, such as at Memorial Park. Linklater Reserve is so obviously the best place for dogs that my son and I drive regularly from Ashhurst for the opportunity to let our dog run and get some good off-lead exercise. Our dog is a "hand-me down" dog; he was already adult and had anxious behaviours when we got him. It was hard for him to be around other dogs for a little while. Through socialisation at Linklater Park, he is now better behaved everywhere, on- and off-leash. On rare occasions I see dog owners who are nervous at Linklater. I remember being nervous there when I first had my dog. There are lots and lots of places to take dogs on leash if people need to be controlling of their dog and other humans and other dogs. Loads. Everywhere. We need more fully fenced dog parks that are really good for exercising dogs together, not fewer. Please write down any other feedback you would like to share People who are controlling complain loudly. with us about our proposal. As an example, I am part of the group that developed the community orchard in Ashhurst. This is loved by many, however, council responds to complaints and the volunteering of many people and the enthusiasm of many people was often in conflict with a very few loud complainers. I burnt out and I now leave it to others who are less affected by this sort of social friction. Thank you for taking consultation instead of just jumping straight to listening to the front desk complainers over all others. What made you want to give feedback on this consultation? This park matters greatly to me, my son, and his dog. It's a really important part of our life. It's a way that my son and I bond with one another, and our dog is so much better behaved than we got him as an anxious adult. He had to learn to be with other dogs and it took a little time. We never have problems. Every six months or so I see someone who is unhappy with the dynamic there. We and others work to keep our dogs separate in such cases. There are so few places we can go. It's not just about the dog: it's about the dynamic with the family. Please leave the park as it is.

By adding on-lead restrictions it defeats the initial purpose of this park. My family regularly use the park with our daughters and dogs and have never had any issues with off-lead dogs.

We have young children who like to play with our dogs and the most usable area for this is the initial entrance off Tremaine Avenue (largely due to the age of our children and the distance to travel to the back area). I think Linklater Reserve is a fantastic resource for Palmerston North. We used it extensively when we lived in Palmerston North and have continued since we moved to Feilding. It is great park because it is a fully fenced which provides peace of mind for dog owners. As a result it is very well used by many dog owners in the region.

I fully understand that the reserve needs to be accessible for all members of the public and not everyone is comfortable with dogs running around. As such in principle I do not oppose part of the park being on leash. I think the proposed area does not make sense. If part of the park is to be on leash, it would make sense to be the front park of the park which includes the playground and flying fox. It makes no sense to have the part of the park that contains the agility course on lead. It is unsafe for dogs to run the agility course on lead in case they fall off and strangle themselves. That part of the park is essentially open grass as well so it makes no sense why that park would be on lead. If it is to do with the plane then it would seem to make more sense to move the plane into the front part of the park. It would also be much easier to fence the front part of the park as it is essentially already fenced. Only some gates would be required. If the Council proceeds with the current plan, more extensive fencing will be required which would be more than the cost of moving the plane. I also suspect if the Council proceeds as currently planned, many dog owners will no longer use the park as a large part of the park would be on leash. We were there today and essentially every user of the park had a dog. It would be a real shame if such a great resource was denied to the many dog owners in the region. There are many parks in Palmerston North but no others like Linklater Park which is safe and fully fenced for dogs. I accept all members of the public should be able to use the park but if they have an issue with dogs, there are plenty of other options open to them. There are not other safe options for dog owners to take their dogs. If part of the park is to be on leash, the current proposal is too much. I also note that most of the open area proposed to be fenced (where the dog agility area is) is open grass. That is hugely beneficial for dogs to run off leash on but I do not see what use that will be for non dog users.
