I can't see a gated fence/ barrier between the two zones. Putting such in place may help with compliance and decrease the fear that an off lease dog may run over the boundary to have a snarl or snap at you.

Compliance could be a problem as I have found about 1/3 of dog owners ignore on lease and most people with a healthy concern for their safety feel too anxious to approach these owners to ask for respect of the bilateral. The joy of Linklater park has always been the community of other dogs and dog owners interacting - dogs running and playing together, swimming in the wetlands area, and the ability to mix up the routes depending on time available. When we lived closer and went every morning there would be a large group of familiar folk and dogs who mingled; some of the folk and dogs were elderly and couldn't make it far from the car park but would always do the first paddock as far as the bridge, or when things got really uncomfortable let their dogs in to play with the others while they stayed at the fence. The whole appeal of Linklater park for us is that it is off-lead, designed for dogs and dog owners of all ages and energy levels. There are many PN parks which are on-Leash only - this one is fully fenced, expansive and welcoming of all. Or it was....

Cutting the off-leash area down so much would be awful, so disappointing. And I assume the dog agility course would have to be moved because you don't want to try and do that with a dog on-lead. And excluding the wetlands area takes water-play out of the options for dogs because few owners will go in there on leash. No. We thought the park had been designed with dogs in mind. Please leave it that way - we travel far now to it especially for that reason: it's fenced, it's big, and like any facility it's only a very, very few who abuse it. Don't restrict all for the sake of the few.

Please write down any other feedback you would like to share with us about our proposal.

If you feel you have to make a restricted, on-lead only zone, make it smaller than the proposed area. Fence across the tree line behind the bike pump-track, fence down between the flying fox and the wetland. Let the dogs be free to fling themselves into the water - its joy, its life, its fun. I always hoped the council would encourage coffee carts to set up at the entrance.... I get the feeling there are more barriers (costs) to the operators to this than benefits, but it shouldn't be about revenue generation for the council, more about enabling small businesses to offer, try something the public might enjoy and add to the park's appeal. Encourage, don't discourage.

I would also LOVE to see a dog-wash station installed near the car park I would spend \$10 /wash there regularly as part of the walk! Again, resist the need for greed /profit - do it for the community first, and keep it in the reasonable price range to encourage frequent use.

What made you want to give feedback on this consultation?

Because this really matters to us as dog owners. Linklater park is special because of its expanse and how well it seemed to have been designed to encourage dog walking and outdoor exercise, without overregulation and constraints, and no fast cyclists (as met on the river bridle path). Let this park stay devoted to that intention. There are plenty of other parks and walkways nearby which dog on-lead advocates can use if that is their preference. But this space is ours and we are horrified by the threat to diminish it.

Please tell us why.	Linklater Reserve is a unique asset to Palmerston North in that it is a wide open, fenced, off-leash area for dogs. You could argue that the Manawatu River pathway is a similar place, and it is similar but not the same. When the river is in flood Linklater Reserve is a much safer place for dogs and owners to get the same level of exercise they would at the river, and the same socialisation with other dogs. Socialisation should not be undervalued and the availability of free facilities like Linklater Reserve allow people who can't afford services like doggy day care to socialise their dogs. Having brought our dog across from the UK, where dog access in public is far more widely permitted, I can say that our dog is much better socialised than if we hadn't been able to take her to cafes or pubs, on the train and bus and through town. We are also far more conscious as owners of the responsibility and duty to socialise our dog, train her properly and be aware of how other people feel around dogs. The way to train animals is not to limit their environments, in the same way it doesn't benefit children. Linklater Reserve IS that safe and controlled environment for young dogs and new owners to learn skills and how to coexist in a socially acceptable way. Kids have parks to do this (so many parks), please keep Linklater Reserve as it is for the other species we call family.

Primarily, I do not agree that a dog agility area can be used on lead. This proposal currently adds benefits for children including those who wish to climb the Cessna, but this means that dogs will not be able to fully use the dog agility area, as some parts of the agility area require dogs to be off lead (eg the tyre jumps.)

Secondly, the majority of users seen in the park are dog walkers, including families with dogs, particularly in the morning and later afternoon, and they are being penalised by their use of a circuit of the existing park to less than half. Dog walkers walk their dogs all year round, and in all weathers whereas the park is used by children more only during school holidays and weekends. There are also other parks for children to play in the surrounding residential areas, where dogs cannot go off-lead.

If the council has to change this precious facility and restrict the off-lead areas for dog walkers, then make it along the hedgeline behind the bike track. If really necessary to meet these restricting requests of the Kelvin Grove residents (who already have Kelvin Grove Park, and Celaeno Park Playground, as well as Kaimanawa Park and several other reserves), to include the Cessna, then move the Cessna into the proposed on-lead area in the lower paddocks 1 or 2, but please do not restrict the greater areas for the majority of regular dog walkers/owners to just the top of the Linklater Park. This is a Palmy treasure that has to work for the residents too, but not to upset the majority of the regular current users. As a compromise, make the main playareas, ie the first 2 paddocks including the flying fox, wetlands and play areas on-lease, but not the dog agility field please. Please leave these top 3 paddocks to the off-leash exercise of the majority of the regular users dogs.

The proposed change

No, I don't support this change
I do not support the proposed changes at Linklater Reserve that would see half of the space — including the wetlands area — turned into an on leash zone. As a local resident who lives within walking distance of the park, this change would have a significant negative impact on my daily routine and my dog's wellbeing. I manage ongoing health issues, and Linklater Reserve is one of the few places where I can easily walk to and allow my dog to get the exercise and stimulation she needs — without the physical demands of a longer walk to other parks or areas. Converting part of the park, especially the wetlands area, to on-leash use would mean that the most interesting and enriching part of the park for my dog would become inaccessible for proper exercise. Additionally, there are many other parks in Kelvin Grove and surrounding suburbs where on-leash walking is already required. Linklater is one of the few dedicated off-leash spaces, and it plays a vital role in promoting responsible dog ownership, canine socialisation, and community interaction. Please keep Linklater Park fully off-leash. It's more than just a dog park — it's a lifeline for many in our community, including those of us who face physical limitations.
While I don't support the proposed change, if the council decides to go ahead with it, I would suggest placing the new fence at the first tree line, where there is already an existing fence. I would also like to see an additional fence built to exclude the wetlands area on the left as you enter the park, so that this space remains part of the off-leash area. This layout would allow the dog agility area to stay within the off-leash zone, while keeping dogs out of the remaining children's play areas. I believe this would be a more balanced outcome — one that preserves the most engaging and natural areas for dogs, while still addressing concerns around shared use.
I wanted to ensure the council hears from everyday users of the park. I think there are fairer ways to meet everyone's needs than what's currently proposed.

There's a natural boundary already in the Linklater reserve by the tree line that separates the bike track and the dog agility area. It is recommended to use this natural boundary (already has a fence through the trees and requires the installation of gates (x2) vicinity of the pergola and the other by the water hole. This will then secure the area where there is the playground, the flying fox and bike track making it safer for those using the space but who may or may not bring a dog along. Responsible dog owners who travel out to the fringes of Palmerston North specifically to Linklater reserve do so to benefit from the large grounds available for off leash exercise and socialisation. It doesn't make sense to have to have your dog on leash when undertaking the dog agility course. Not to mention that there are a number of other parks that are suitable for kids and those that don't have dogs to visit e.g.: Memorial park.

Recommend from the carpark at Kelvin Grove to pergola treeline to be ON LEASH. The rest of the park to be OFF LEASH.

Dogs need a large exercise area. Suggesting that Linklater park is to be shared 1/2 with on and off leash areas does not adequately take into the account the amount of space large dog breeds need, nor does it take advantage of the natural boundaries the park areas already provide. Linklater (out in the fringe of Palmerston North) is now being targeted, and yet there are multiple other parks that are specifically ON LEASH only or no dogs allowed. This approach to downsize Linklater begs the question about why other parks can not have zones in place too to promote on and off leash areas.

I'm writing to strongly oppose the proposed change to introduce an onleash area at Linklater Reserve.

As a local resident, this reserve is one of the few truly inclusive spaces in our city where I can bring both my children and our dog to enjoy the outdoors together. The current off-leash policy works well, especially with clear rules already in place around children's play areas. I've always found the open layout and visibility at Linklater Reserve make it easy to monitor both kids and dogs, creating a safe and social environment for families and pet owners alike. My children are 1, 3, and 5 years old and walking to the aeroplane with kids and a buggy and a dog on lead is too difficult - it is too far and the kids just want to play at the swings or the tractor and balance beams. We usually don't even make it any further. Often my husband takes my 5 year old on the zip line and having to stand there holding a dog on a leash the entire time with completely change our experience. In fact we don't use the area at all because our dog is a bit golden retriever and requires an off leash walk. If we can't walk him off lead here we won't come at all as what is the point. We go here to "kill two birds with one stone" with kids having fun and dog having a run. Where else can we do that in Palmerston North?!

Turning a central part of the park into an on-leash zone significantly reduces the freedom and usability of the space for dog owners and will unfairly impact those of us who rely on this park for daily recreation - a lot of people!! Rather than promoting shared use, this proposal risks fragmenting a space that currently balances the needs of both families and dog owners well.

I urge the Council to keep the current off-leash rules in place across the whole reserve (with dogs still excluded from the playground areas), and to focus on education and signage to support responsible dog ownership, rather than restricting access.

What's especially frustrating is that this proposal goes against the feedback you asked for. Earlier this year, you invited residents to share our views, and many of us clearly said we supported the existing offleash rules. To now see a proposal that contradicts that input makes it feel like our voices haven't been taken seriously.

It is incredibly discouraging when community consultation feels like a tick-box exercise rather than a genuine opportunity for residents to shape decisions. If the majority of people supported the current off-leash arrangement, why is PNCC now proposing changes that go against that? It gives the impression that the outcome was already decided, regardless of what the community said.

Linklater Reserve is already a well-used, well-loved park. There are many other areas across the city where leashed dog walking is already the rule. Rather than restricting this space, PNCC should be championing it as a model of shared use, with good signage and responsible pet ownership encouraged through education—not unnecessary rule changes.

I urge you to reconsider this proposal and to respect the feedback your community took the time to give. Please keep Linklater Reserve a truly shared, off-leash space for families and their dogs.

What made you want to give feedback on this consultation?

I wanted to give feedback because I'm genuinely frustrated and disappointed by the direction this proposal is taking—especially after residents were asked to share our thoughts earlier this year. I took the time to respond then, and it was clear that many people—including myself—valued the current off-leash setup at Linklater Reserve and

didn't want it to change.

To now see a proposal that directly contradicts that feedback makes it feel like our voices haven't been heard, or worse, that the consultation wasn't genuine in the first place. It's disheartening when you're invited to participate in a community process, only for the result to feel predetermined.

Linklater Reserve is one of the few public spaces in Palmerston North where I can confidently take both my children and our dog and enjoy the space together. The open layout, visibility, and well-established community use make it ideal. We already have rules in place excluding dogs from the playground, which I fully support, but adding further restrictions seems unnecessary and out of step with how people actually use and enjoy this park.

I'm giving feedback because I feel strongly that PNCC is making a poor decision here—one that ignores public sentiment and undermines a space that's currently working well for families and dog owners alike.

I do not support this change for the following reasons:

In my own experience as a regular park user (multiple times a week) the majority of users I see are dog owners. This proposal has been brought about by a minority of individuals (~60 signatures from the Kelvin Grove Community Association).

It is clear to me that there has been no data captured relating to park use, I hypothesise you would find the majority are in-fact dog owners.

This change is not in the interest of of rate payers or park users due to the cost of the changes, and the interruptions to park use that this will bring. There are far more important issues within our city such as our ageing infrastructure which would be better allocation of rate payer funds.

These proposed changes essentially cut off all water access for dogs, and requires the expensive relocation of the agility course and fencing. This is an absolute waste of ratepayer dollars.

Linklater is the only park in Palmerston North that provides a safe, large, fenced in area where dogs can run, swim, play and walk without restraint. Alternatives such as the river are not suitable due to many reasons such as but not limited to:

Cyclists, heavy congestion, the river being unsafe for dogs to swim in (strong currents and terrible water quality). There is no suitable alternative that provides this kind of experience for owners and dogs.

Regular users of the park are a tight nit bunch, we all know each other and each others families and dogs. We treat the park with respect, and we do not want it to change. We also keep our dogs under control, ensuring that other users visiting the playgrounds, playing frisby golf or those having a BBQ are left undisturbed.

Kelvin Grove is full of other parks, to my knowledge there are 11 named parks / reserves. There are plenty of other places that people within the KG community can visit if they are not comfortable with dogs being off leash.
