I have had a situation (at the other dog park down by the river) where the owner knew their dog was a risk to other dogs so they muzzled it, but let it off lead and it tackled my dog to the ground and then I also landed on the ground. The owners just stood there smiling and saying don't worry, he's got his muzzle on, while their dog was trying to maul my dog through it's muzzle. The owners didn't call it off and thought it was amusing. I have also witnessed another small dog attack other larger dogs as it passes and the owner just keep walking in the opposite direction, and not even attempt to stop it or even correct it. In general I have found many people just do not have sufficient control of their dogs, which ruins it for others. I don't even feel safe walking my dog in the parks now.

I walk this park 2 times most days. 70-80 percent of all users are dog users and the majority of them are off-leash. You have a minority attempting to change this park due to a very small amount of issues with off-leash dog users. You are proposing to separate the park for off-leash dog users when there isn't a signigicant issue. This is Featherston Street re-development all over again. In your first request for submissions the majority of over 60 percent have spoken not to change Linklater Reserve. Yet you now request addition submissions. This proposal will come at a cost for the ratepayers with new pathways and fences around the Plane in addition to the moving cost of the dog agility course. Why should off-leash dog users have to have their use of Linklater cut in half? This is not a fair compromise and we are paying for the inadequate planning of the PNCC putting Planes in one section of the park, The agility course in another and so on with the playgrounds. You stuffed this up, we as ratepayers will then have to pay to fix it.. just as with Featherston Street. I mentioned in my first submission that if Linklater was such a 'terrible environment' for off-leash dog users dogs running out of control, why have I never seen a PNCC Dog Control Officer there in my 11 years of walking the park, twice a day? Has PNCC been acting in an unsafe manner not actioning this? No, I haven't seen a dog control office because there is no great concern to the safety of dogs or people and this is a request to the council by a association (Kelvin Grove Community Association) who are out of touch with their community and who are quite honestly a joke. By separating the park you are eliminating the dogs to utilise the extremely popular creek to swim in .. not just summer months when its incredibly important for the dogs to hydrate but all year round. This is not about being fair by splitting the park in half so all can enjoy. This is a direct movement against off leash dogs and dogs and their users as a whole. There are many parks within walking distance for playgrounds etc for those who want to enjoy them without having interaction with dogs. Their is only one off-leash reserve in Kelvin Grove and you are going to rip the heart out of it. What a disappointment our current PNCC Mayor and councillors are. You are so focussed on things that are not broken rather than focussing on your core role. Shame on you.

The Kelvin Grove Community Association is out of touch and their comments on their Facebook post regarding this proposal for Linklater Reserve are quite concerning. Some comments made by the KGCA (hiding behind the KGCA) are disappointing and for me guestions their state of mind. Yet, they are integral in this proposal apparently acting on behalf of concerned residents. I ask you to go onto their Facebook post on May 10th and review the comments made by the KGCA and Val Burr and John Charlton. If you would prefer for me to send a snip of these comments made to me then please advise where I send this to. What I am saying is that The KGCA is out of touch. Val talks about how she used to ride her horse back there in the 1990's and that the KGCA donated \$12,500 toward the flying fox, in addition to the \$15,000 toward the swing bridge. Does this give them leverage for this proposal? I asked John, Val and the KGCA how many of their members supported this proposal to Lorna Johnson and secondly, how often they John and Val use Linklater. I have never got a reply and I am asking the guestion why that is? Why would they not answer? Because they have the support of a very select few and they don't frequent Linklater Reserve much and probably not at all. Yet they are a big voice in making this change. How disappointing that they apparently speak for all of Kelvin Grove.. I know so many Kelvin Grove Residents who regard the KGCA as just a joke.

What made you want to give feedback on this consultation?

Because I am passionate about Linklater Reserve, I want to join the Linklater Reserve working bee's for the development of the reserve but this will no longer be the case if these dramatic changes are made. I walked my dog (now deceased) around Linklater twice a day every day (at least 6 days a week) for over ten years and can count the issues with off-leash dogs on one hand. Yet we want to rip the park apart, conduct work which will be paid for by us ratepayers all for something that isn't an issue. The KGCA are acting on a very small minority and this needs to be stopped and the PNCC need to do the right thing. Listen to your ratepayers and don't repeat the same ignorant views that was displayed with the Featherston Street re-development. If you do, I guess it is election year and the majority have the opportunity to vote.

I am writing to express my strong opposition to the proposed changes to Linklater Reserve, which would see the off-lead area halved and converted to on-lead use. As a Palmerston North resident, ratepayer and regular user of this reserve, I believe this proposal would negatively impact the wellbeing of both dogs and their owners, create unnecessary expense, and would heavily diminish the reserve's value to the community.

Off-lead Areas Promote Dog and Community Wellbeing:
Responsible dog owners rely on off-lead dog areas because they are
essential for dogs to engage in natural behaviours that keep dogs
physically healthy and mentally stimulated such as running, playing, and
socialising – activities which are not possible when restricted by a lead.
Regular off-lead exercise supports physical health, reduces behavioural
issues and decreases anxiety and reactiveness in dogs, which restricting
movement on a lead does and not allowing natural dog behaviours
results in increased anxiety and reactivity. Given the huge popularity of
the park (due in very large part to dog owners), halving the space
allocated to off-lead will lead to congestion and potentially create more
issues than less.

Training and Socialisation for Young Dogs:

Linklater reserve being a large off-lead area also offers those training and socialising young dogs a safe space and a controlled environment to do so, which is critical. Early exposure to other dogs, adults, children, and distraction is essential for developing calm, well-adjusting behaviour. Practising recall, obedience, and on/off-lead manners in a real-world setting helps owners to raise dogs that are safer and more responsible in public. With reduced access to an off-lead and uncongested area, many owners will be left without a suitable location to reinforce these life skills for their dog, potentially leading to more behavioural issues in the community and other areas.

Community Demand and Use of Linklater:

Linklater reserve is already well-used and appreciated as a safe and open space for dogs to run freely due to the large area and the fact that it is fully-fenced. At peak times, the current area is comfortably busy, suggesting high demand for the off-lead access, while not too congested to cause issues. Reducing the space would concentrate users into a smaller zone, increasing the risk of overcrowding and in turn increasing the risk of incidents and creating a less enjoyable experience for users of the area. If the motivation behind this change is to address isolated concerns, it's important to understand that it may in fact have the opposite result. A more targeted approach such as clear signage, waste bin improvements, or education campaigns may be more effective and equitable.

Personal Experience and Responsible Use:

As a responsible dog owner, I visit Linklater reserve multiple times a week with my two well-trained and well-behaved dogs, rain or shine. I've seen firsthand the positive impact of the current off-lead setup. The offlead space has been essential for my dogs' health, confidence, training and socialisation, and it has been a place where I've met other locals and built lasting friendships and received support and advice. I've always found the environment welcoming, respectful and safe, often taking the kids for our walks and to use the play equipment with no issue, as many other families do. I often see other families, with or without dogs, enjoying the area too. Although I do see non-dog owners regularly using the park beyond the two children's play areas, the popularity and continued use and support of this park is due to dogs and their owners. Unlike other parks and spaces within Palmerston North, not once have I witnessed any attacks or dangerous behaviour from dogs at Linklater reserve. In being a regular user of this park, I have found only positive engagement with dogs, their owners and non-dog owners using the area and have felt a sense of strong and connected community.

In summary, I am strongly opposed to the change proposal and believe

this change will have a negative impact on the many Manawatu locals, dog owners and ratepayers using this park. This change proposal is at the request of a small minority and is likely to largely decrease the use of the park, reduce dog socialisation and training opportunities, cause congestion, and increase the likelihood of the very situations the Kelvin Grove Association have raised, which are clearly not a common occurrence, having never witnessed any issues despite using this park multiple times per week over hundreds of visits.

There is no other comparable alternative for dog owners in the Palmerston North area. There are however a huge number of parks and open areas, both within Kelvin Grove and in the wider Palmerston North area that do not allow dog access or are on-lead only. These many options provide more than adequate alternatives for those who do not want to walk or socialise in an area with dogs around. I do not believe that a very small percentage of the Kelvin Grove area (those within the Kelvin Grove Association) should be able to dictate and make demands about how an area paid for and maintained by the local council is used by the wider Palmerston North locals and ratepayers.

Altering the infrastructure of Linklater by adding an entirely new fence and gates will incur significant costs. In the current economy, the amount proposed to make changes for a very small minority of people who take issue with this space, (when the clear majority of those who have provided feedback in the first survey do not support this change), doesn't seem justifiable. The ongoing costs of monitoring and enforcement of these new restrictions would also likely cause additional costs that would be better focused elsewhere within the electorate.

Based upon my experience as a weekly user of Linklater Reserve for the last 3.5 years, I believe the KGCA is overstating the extent of any problems caused there by uncontrolled dogs; I personally have never witnessed any issues at this Reserve. 2. While there have undoubtedly been some problematic incidents, these can and do occur in all public spaces; my own dog has been attacked and severely injured twice elsewhere in this time (including once by uncontrolled ON-leash dogs). 3. The reduction of the off-leash area by 50% is unwarranted and unnecessary. 4. The existing rule prohibiting dogs within 30 metres of play areas is sufficient. 5. In my experience most dog owners avoid the main play areas anyway; people with dogs that are in those areas are generally there playing with their children and have chosen to bring their dog along. 6. Concerns around issues at access points to the Reserve can be dealt with by having separately designated entrance gates. 7. The Council's "educational" approach to non-conforming owners needs to be reviewed in light of some dog owners continuing to act with impunity. Otherwise responsible dog owners and their dogs will continue to be disadvantaged; this current proposal by the Council being a case in point. 8. Dogs need wide, open spaces to run in. As the population of PN increases, so too will dog ownership; having a sufficiently large off-leash area will become increasingly necessary and important. 9. The land for Linklater Reserve was purchased by the Council with revenue gathered from ALL its residents. It was not gifted by the KGCA (or the Linklater family), and I do not accept their reasoning or rationale for why they should have an undue say over its future use. I go there occasionally, but sadly there is not much to see there nowadays unfortunately.

I strongly believe that the general public should have safe access to the lower part of the Linklater Reserve, and that they shouldn't have to avoid the park entirely simply because not all dog-owners who go there have total control over their pets when the pets are off-lead. Pet ownership is a hobby of sorts, and I don't believe that PNCC should be funding a massive c70 acre (c28 hectares) park to the exclusion of the bulk of the city's population, let alone Kelvin Grove's. My reference is to the 'off-lead' dog-ownership population. I'm perfectly comfortable with the on-lead dogs being all over the park.
	I am going to start with the letter I wrote that was published in the Manawatu Standard on Friday, 18 July 2025, as that saves double handling information:
	"Let Linklater Reserve be safe for people "In response to various people snarling about dog parks, Kelvin Grove has long struggled alongside council, separated by a territorial boundary a railway line and nowadays an industrial zone.
	"The suburb's first house was built in 1966. Two dairies and a fish and chip shop opened in 1981. The previous year we inherited the former Centennial Pavilion — which received its first car park in 2023.
	"In 2012, the supermarket and some adjoining little shops opened. There are two "special-interest" schools, but most kids leave the suburb to be educated. Oh yes, we have a cemetery.
	"Circa 1993, Palmerston North City Council began plans to buy the future Linklater Reserve. Theoretically the city's "second Esplanade", finally Kelvin Grove would be noted for something exciting, no longer jus "the dead centre of Palmerston North"!
	"At an open day in 2001, the council explained their plans. Tree-planting followed, and all seemed wonderful. Dog parks weren't mentioned.
	"Then around 2011 and seemingly without consulting the locals, their interests were superseded to those of roaming dogs. Furthermore, these dogs were (apparently) drawn from well-endowed suburbs all over the city.
	"Our under-resourced suburb lost again. Roaming dogs got the swing bridge and flying fox Kelvin Grove Community Association contributed \$27,500 towards, plus the public toilets, barbecue area and unfenced children's play equipment dogs aren't allowed within 30 metres of.
	"In reality, I've heard no objections to dogs being at the park. Simply that people should also be able to enjoy part of it without fear of encountering potentially uncontrolled, aggressive dogs.
	"Instead people abuse us, saying we should travel to random distant parks — rather than enjoy this interesting historic farm/park right on our doorstep."
	As many of you will know the stone time (almost all my life) Kelvin

As many of you will know, I'm a long-time (almost all my life) Kelvin

Grove resident. Our dairy farm, at its largest in the 1960s to mid-1970s, ran from Napier Road, up through part of Kaimanawa Street, and out to Roberts Line. This is relevant as it bordered the Clyde Crescent State Housing subdivision and we had to endure swarms of roaming kids, including some with dogs.

I've been a member in various capacities of the Kelvin Grove Residents'/Community Assn.'s committee since the mid-1980s. I've also known the Linklater Reserve property since I was a little kid in the latter 1950s, and I'm familiar with its history back to the 1870s. I also grazed one of my horses there around 1990.

I've never owned a dog in my own right, but we had farm dogs until I was in my 20s. They enjoyed running around loose when not working (or secured) – resulting in one pup ('Brownie') getting killed by a HB-bound goods train beside where the Mihaere Drive overbridge now is (a graphic scene I will never forget); and another ('Brownie's' sibling 'Lizzie'), by then a beloved pet and no longer a working cattle dog, getting shot by a neighbour while chasing someone else's straying dog that was chasing sheep (as we were told by our shocked neighbour who recognised her too late – including knowing she was his own dog's daughter [that Mum subsequently accidentally ran over and killed on Roberts Line]).

Another stray we kind of adopted (a town dog we named 'Goldy'), slipped his collar and ended up shot immediately after he chased my pregnant horse ('Dusty') through a gate and left her with two major gashes on her left abdomen and flank, and 18 stitches. I was horrified when I got home from work that day and discovered what had happened to both. A town dog also attacked our pet goat ('Jenny') and we ended up with her blood all over our front porch. That dog got away unfortunately. The goat survived, and so did my horse. My point is that dogs don't always do the right thing by themselves or by other animals, and that extends to how some treat humans.

In addition to this, I'm also one of the two admins of the Kelvin Grove Community Assn. Inc. Facebook page, and that has been my main point of contact in this present matter — or rather it has been a bit of a nightmare. The other admin has been away for several weeks, and so I've had to cope alone with a number of typically 'nasty' comments by 'keyboard warriors' who have no consideration for sharing that huge park with any other people or animals. You are welcome to read through all the many comments left on the Kelvin Grove Community Association Facebook page. I haven't deleted any — but the person I mentioned last time as living in Alaska, deleted hers. The PNCC Facebook page also has many rabid comments beneath its Linklater Reserve posts. In fact I'd recommend that you read them. If these people's dogs are anything like their owners, than probably that's where the clash begins.

Some dog-owning people have very reasoned arguments and a high degree of understanding as to how some dogs that are taken to the park and turned loose, have no means of control. Other posters though rave on as if the park was purchased specifically for dogs to roam about on (which is total rubbish), and how no-one else has any rights to be there. There are complaints that children's play equipment should never have been put in a "dog park" – without the person/people comprehending that it was a park before suddenly someone decided it was 'primarily' for freerange dogs and thus 'who cares about anyone else'. It was an operational farm before that - and it never was merely wasteland! Some demand to know how often each of us personally goes to the park (it's mid-winter!). The answer would usually be "sometimes", but that's because the attractions at that huge park are outweighed by the freerange dogs.

One person has left about 30-40 comments – droning on about the same things. When I finally responded "Yaaaaaawn" and suggested blocking him, he apparently (unsuccessfully) tried to get Facebook to shut down our Facebook page.

Someone raved on about how Ross Linklater (and named him) was paid "millions and millions" of dollars for the farmland that is now the reserve, so he shouldn't complain about it becoming a "dog park". I haven't had the chance to tell Ross this snippet yet, but my first reaction was that if PNCC paid whatever "millions and millions" translates to, then surely the rest of us who don't have dogs, have the right to expect dog registration fees to be radically increased in the hope of recovering some of that cost to spend on the potholes and so-on.

I deeply resent how people from all over town should demand that local Kelvin Grove people should leave the area to go to other parks, instead of one on their doorstep. There are dog parks all over the city according to the Palmerston North Dog Control Policy 2018 – and the subsequent 2024 one - including three other off-lead reserves in Kelvin Grove. Perhaps PNCC needs to publicise such information somewhat better?

I've had people rave online about what they assume to be my attitude to dogs in general, especially after I pointed out that my daughter was attacked by a dog when she was about six (at the dog's home, when it broke out of a shed it had been placed in theoretically for the duration of our visit). The response was like "Aaah, so that's why you hate dogs" – which is rubbish. Rather, it means I know what it's like to have a terrified screaming child desperately clamber up my body trying to get out of the reach of the attacking teeth – before the owners managed to drag it away seconds later before much damage was done.

Similarly, I also know what it's like to  $-15\ years$  later - clean up a metrewide 'pool' of her dried blood from the concrete floor of her flat after she was murdered. The police's cleaners cleaned the top of the carpet. We removed the carpet. Unfortunately the most vociferous dog-owning 'keyboard warriors' seem to have a very one-sided view of the damage that can be caused when someone is attacked – many media reports from various places suggesting that they typically (or seemingly) just cut and run, without leaving contact information or offering to help the victim either financially or at the scene!

The Kelvin Grove Community Association itself has also been routinely insulted by these people. Presumably 'they' (the 'off-lead' dog park folk) claim to be great contributors to our Kelvin Grove community or the like, but they don't seem to actually 'do' anything. Our group traces with a few twists and turns back to 1901, and has achieved many things over the past 124 years, including community and wartime work – and yet 'they' (the off-lead dog faction) claim things like that we consist of only five people who apparently do little beyond annoy the 'keyboard warriors'. It's hard to take people seriously when they never seem to visibly do anything for this community. Perhaps fundraising for a new dog-proof fence across the park and/or actually building it would be a good way to prove 'they' can do something for this community besides rave on social media. And of course the ones living outside Kelvin Grove probably never contribute anything to the suburb – because 'they' already have all the good stuff we don't have, and basically 'they' don't care about Kelvin Grove beyond turning their dogs loose in it anyway.

I'm extremely conscious of the poll conducted earlier in the year on the PNCC Facebook page – but not for the reasons assumed. Rather, several years ago there was a similar poll on the PNCC Facebook page relating to whether outdoor gym equipment should be in Ashhurst or Kelvin Grove. Ashhurst's votes were soon massive, while Kelvin Grove's really dragged. Then I happened to trip over someone's pro-Ashhurst-siting comment on some Facebook page – explaining how to jack up the votes repeatedly by one person voting over and over again. I was stunned. I tried what they said with a single extra vote (as I'd already voted), and it worked. So personally, as a result, I'd put no faith whatsoever into any polling vote on the PNCC Facebook page.

So, as stated above, perhaps the off-lead dog fan club could crowd-fund the money to build the proposed dividing fence across the Linklater Reserve. I bet they wouldn't dream of doing that though. They instead

expect the ratepayers of Palmerston North to finance everything – while still only paying their tiny annual dog registration fees to accommodate their dog-ownership hobby.

And now to the personal impact of this latest performance. My neighbour on our shared driveway has had her letterbox kicked over six times (so far) in the last few weeks. It's hard not to wonder why this is happening – and not to other identically set-up letterboxes nearby along the street. One other did get knocked over (twice) two doors down from us at an unoccupied house, but why not the others. I wired it up for her 1½ weeks ago, and about 90 minutes later I heard it kicked three times and rushed out to check it. It had been kicked over to the extent where the wires allowed it – and where it remains. Meanwhile, its pipe stand is on the verge of snapping and the box itself is partly broken off its mount. Perhaps this relates to the "dog park" issue, or perhaps not – but we are very conscious of it and general security at the moment. My letterbox is less accessible to kickers.

Also, in terms of intrusions, several weeks ago, while preparing the latest parole submission relating to my daughter's killer, I had to deal with more pro-"dog park" fans. This parole submission was a particularly hard one to deal with (for a specific reason unrelated to "dog parks"), and so when I checked out one of the commenters and discovered that she worked for the funeral director that buried my daughter, I was rather upset. I forgot to ask her if they'd give a discount on a funeral for any little kid that happened to be killed by one of the roaming dogs that she supported. But then my life experiences are radically different to the average "dog park" fan. By observation and messages through the KGCA Facebook page and its behind-the-scenes message system, usually when people's dogs attack people or other dogs, the owner of the offending dog claims they've never done it before – and bolts without leaving their contact details. Too bad if the damage has resulted in a huge vet bill – like the \$1,000 one from a few weeks ago.

Lastly, KGCA did our submission on this topic some weeks ago and then our chairman John Charlton and fellow committee member, Ross Linklater, and I participated in the subsequent Council 'event' relating to the somewhat 'last minute' petition we threw together. In John's absence at present (until after the deadline), the rest of us are handling things as best we can. Over the years I've been involved in various things to get information to and from the Kelvin Grove community. The intention was to do the same with this one, but given the way I/we have been treated by the pro-"dog park" people, it's a case of 'like hell'. I recall how terrifying it was to deliver leaflets (with my name on them) throughout the entire Kelvin Grove community in 2000 offering people the chance to attend a special support meeting a few days after the Lundy murders. Well, that was far less scary (i.e. worrying about attracting the attention of a then-unknown axe murderer) than anticipating a potential face-to-face meeting with a pro-'dog park' person (and their dog/s).

I also believe, like I have from the start, that the plane should be transferred to where it's visible from Kelvin Grove Road – because the people frequenting the top of the park have done a horrific job of looking after it, despite the best efforts and hopes of PNCC's staff. I have researched that plane's story including in the US, and the history of that former air ambulance (and its slide) would be more appealing to kids in the lower park than it clearly has been to the people who go up to the top of the park with their off-lead dogs.

In addition, perhaps someone can explain why dogs are proposed to be allowed "within 10 metres of the children's play spaces and play equipment" seemingly at the Linklater Reserve only – instead of 30 metres? Hopefully that really is due to the issues stated in the 'Statement of Proposal' document, and not because someone thinks that uncontrolled dogs ripping Kelvin Grove children to bits is socially acceptable?

Postscript: I could have added photos of 'Brownie', 'Lizzie', 'Goldy,

'Jenny', 'Dusty' (high on cocaine apparently and with dried blood left on her coat from her two large newly stitched gashes), my late daughter as a very vulnerable 6-y-o around the time she was attacked, a diesel loco and a Triumph 2000, but figured that I'd been graphic enough. Uncontrolled dogs should not be near vulnerable people or other animals of any species – no matter what the 'off-lead' faction thinks. And PNCC should not be funding such a huge park simply to accommodate some pet-owners' hobbies.

#### What made you want to give feedback on this consultation?

Because the park began as a "second Esplanade" (in 1993) and then some years later it suddenly transformed into something many people are too afraid to go near - based on numerous comments and incidents over the years about negative dog encounters. It was never 'wasteland' - and the off-lead dog fans need to justify why they shouldn't have had their dog registration fees radically increased to pay the park's costs. In most cases dog-ownership is a hobby, and there seems to me to be no reason why PNCC should finance this hobby - including at the expense of many other people.

My small dog and I walk at Linklater Reserve most days, and have done for years. We both love walking here for the freedom and opportunities to explore it provides. We meet hundreds of people here every week who clearly enjoy the same thing. People of all ages, solos, couples, families with kids and babies, people with dogs and people without dogs. But mainly, yes, people with dogs.

The statement of proposal says: "We know that Linklater Reserve is one of the most popular parks in the city, so we need to make sure that it meets the needs of as many people as possible."

I'd like to offer a different perspective. Clearly, the reason it's one of the most popular parks in the city is because it is exceptional at meeting the needs of a particular group of people: that is, people with dogs. Given there are more than 9,000 dogs registered in Palmerston North, it's hardly surprising the park is so popular.

While Palmy has more than 100 parks, only a small fraction of these have off-leash areas. And none of the other off-leash areas provide the utility that Linklater does. For example, though my dog is well behaved, well controlled and has good recall, I'm never going to walk her off leash on the Railway Land. It is nuts to me that this is a designated dog exercise area, bordered by a state highway and with a skate park at one end.

I love the varied terrain you get by walking the whole park, and being able to sling the leash around my neck and walk with my arms swinging free and my headphones on, listening to books. Winnie is always under my control but can run about and sniff to her heart's content. Her favourite thing to do is paddle in the wetland ponds - something she won't be able to do if this area becomes on-leash. I've never felt threatened by other dogs at the park.

This is in stark contrast to the Manawatū River pathway, which although it's a designated dog exercise area, is somewhere we don't walk because we don't feel safe. Even with Winnie on a lead, I feel threatened by speeding cyclists who treat the area like a race track. Obviously I can't wear my headphones at the river and enjoy a book while I walk, but even so, I am partially deaf so the bikes still take us by surprise. It's simply not a relaxing place to walk in the way that Linklater Reserve is.

There are other parks in the city I can't take Winnie at all, such as Memorial Park. This is a beautiful shady place to be in summer. It's the closest park to my house. But we don't ever go here, and can't, because dogs are prohibited. So we go to Linklater instead.

I can see a situation whereby dogs will be let off leash by owners who go super early as there's no one there only dog people. So why not make it time based for week days so these owners are not breaking rules. Weekends are different as people do stuff early as there's no school/work etc.

Hope this makes sense?

On another note: a couple of times a year the local school does their fun run around the whole perimeter of Linklater, that means a whole swag of kids will be running round the off-leash area. Dogs and kids get along fine during this fun run.

In light of the Kelvin Grove Community (a minority group I may add), citing dog attacks, will the school still be able to do this or will they be confined in the on-leash area only. Linklater Reserve is a uinique asset to Palmerston North It has wide open areas that are perfect for dogs. Having space for dogs to exercise is critical to the social development of these companion animals. I am sure that the reserve contributes to positive dog behaviour in our city.  This proposal cuts out a large area of the reserve that is perfectly suited for off-leash. This proposal places the dog agility area within the on-lead part of the reserve - this makes no sense. Dog agility by its definition is about animals off lead. The proposal as presented will marginalise the use of the agility area - this is not an area that has any other use. I completely agree that the southern area of the park, with the bike track flying fox, log scramble etc being on lead. This area is for families, and people who are not confident around dogs needs to feel safe. But the proposal as presented cuts out a large area across the middle of the reserve that is perfectly suited to dogs off lead.

I appreciate that some people and dogs prefer on-leash areas however, the majority of users at this location do not. There are multiple other parks for these users which are not accessible to dogs. I do not agree with the location of the proposed boundary as it does not make sense. The vast majority of the non-dog amenities are in the front third of the reserve, with only a few disc golf locations and the plane further back. Please amend the off leash area to the current fence-line 1/3 of the way back. People not comfortable with off-leash dogs can still enjoy the facilities -and there is a larger area for off-leash dogs to have a proper exercise area. This is an existing fence-line and will only need minimal changes to implement, saving Council money. With this fence-line, the dog play equipment will also not need to be moved (or removed). Over 90% of people in this park are there to exercise and socialise their dogs and the current proposal is excessive to cater for the other 10%.

Please write down any other feedback you would like to share with us about our proposal.

Smaller off-leash areas are fine for small dogs but do not cater for larger/more active dogs to run and have adequate stimulation. Elderly/less agile dogs and owners might not be able to walk to the proposed off-leash area. While there is a small carpark at the back, it will not be big enough to cater for all dog users.

This will likely push more dog owners to the river walkway which is used by a bigger cross-section of the public. Will this then also be taken away or restricted to on-leash as more dogs use this area off leash? Will there be eventually nowhere to adequately exercise dogs responsibly? Will this increase aggressive behaviour and barking complaints? Is the problem bad behaviour by a few? Is there even evidence of any bad behaviour or complaints? Why punish everyone else for allegedly a few people/dogs? Dogs need adequate stimulation and exercise which cannot be achieved on-leash.

What made you want to give feedback on this consultation?

One of the key factors to our recent move to Palmerston North is that it appeared to be dog friendly and have reserves such as Linklater where it is filled with happy dogs and responsible dog owners. I believe this reserve should formally become a Dog Park by identity and there should be in infrastructural changes. There are endless schools and playgrounds and high value children's play areas that are far more accessible for young and old people, with many more amenities already available.

What makes Linklater reserve so unique is the fact that its a dog park. People come from all over to go there. It will never have the natural features of the Esplanade or the special amazing equipment of Memorial Park. Dogs are very limited as to where they can be off lead. Any issues that occur at this reserve - aside from being nowhere near the levels of constant terror or daily frequency espoused by the Kelvin Grove Community Association on facebook - are Dog owner issues and those same issues occur everywhere a dog is. I have a menacing dog but I cant take him for walks on the footpath because despite the bylaws stating the footpath is 100% on lead, other dog owners figure seeing as their dog is NOT menacing, they should have unlimited freedoms above the law and the community. The problem is people. There are no 100% safe dogs or dog places but if we assign Linklater an identity as a dog park we can start to work towards a set of shared rules that make the reserve more manageable by its community. If Dogs are a priority in this one area, than families can make choices about where to take their little ones - considering they can go to far many more places than dogs can. How many people actually get attacked by dogs? How many dog attacks happen each year? How many people use this park in a week? Why are the children and old people feeling so excluded from this ONE SPACE in the township when everything they could possibly ever want is already in place all around the city. Leave Linklater the way that it is. Let dogs and dog owners have something nice too - include us in the whole of the Palmerston north community. Just because I don't have kids, doesn't mean I shouldn't be able to find a space for me and my dogs - but if families with children are more important than I am can I get a "you're not as important but we still want you to pay" discount on my rates? Being childless does not make me a second class citizen. Sometimes, the kids and families don't have to be the most important thing in a space. Its OK to celebrate different types of families. There are more kinds of families than ones with elderly and children. Last note, after you have spent a tonne of money shifting things and moving equipment and writing rules and putting up fences and advertising the new rules and making billboards etc - how are you going to enforce it? By perhaps spending even more money hovering over dog owners from Dawn till Dusk 7 days a week? As a person who regularly walks there I can tell you anecdotally we just wont do what you say. But as rate payers, we will be paying for expensive pointless and misguided ventures on behalf of a small community association (and possibly the councillor who has this as their own personal project) who get their information off facebook. And you are going to do it with money that could be much better spent on making an actual difference in peoples lives.

Your proposal suggests we invest a tremendous amount of money solving a non- problem. The Kelvin grove community association is NOT a democratic or even open society and they should not have this much sway over council. Where are the minutes from their meetings? When are the meetings? I am very suspicious that someone in council is biased toward subservience to this small group of people and therefore are not truly representative of public interests - they are just people in power with pet personal projects they're hoping to accomplish for personal aims. How disgusting - those councillors shouldn't be on council if they refuse work with or listen to communities who see things differently to themselves. Those kinds of councillors do not serve our community. They serve themselves. In truth the Kelvin grove community association do their business on the curated, algorithmic and targeted

audience space of Facebook - and is that a good enough threshold to spend rate payer money on? Facebook is a vacuum of self referential ideas and one sided targeted information and audiences. So we are wasting council money because people got excited on facebook? The Kelvin Grove Community Association should not be able to have this title as it implies that they have and execute much more influence in Kelvin Grove then is true. 

I do not feel safe using the walking tracks in Linklater reserve when there are dogs running around off leash. As an active semi retired person who enjoys walking, I would like to use the walking tracks in Linklater reserve as part of my daily walk. I feel that that dogs are prioritised over people in Linklater reserve.

As a Kelvin Grove resident who doesn't own a dog, I would like there to be at least one walkway in Kelvin Grove that goes through bush and wetland that is NOT designated as a "dog exercise area" so that I do not have to constantly drive at least 20 minutes to access "a dog on leash" bush walk. The over emphasis on the council website that Linklater reserve is a "dog exercise area" where "Fido can burn off some energy" prioritises the needs of registered dog owners (approximately 10% of the population of Palmerston North) over non dog owners who may want to walk in a bush/wetland reserve and not have to deal with dogs running around off leash. The nearest bush reserve with good walking tracks in Palmerston North city where dogs must be on a leash is Victoria Esplanade (a 20 minute drive away). Dog owners who wish to have their dogs off leash have access to the shared river walkway adjacent to the Victoria Esplanade (https://www.pncc.govt.nz/Parks-recreation/Walksand-walkways/Manawatu-River-Shared-Pathway); this combination of part on leash/off leash rules provides a more equitable recreation and exercise experience for all residents (ratepayers) in Palmerston North. Designating the whole of Linklater reserve as a "dog exercise area" discriminates against the majority of the population (especially those living in Kelvin Grove) who are forced to use alternatives to Linklater reserve (if they have the time and money available) like "dog on leash" bush walks such as the Victoria Esplanade or the DoC walking tracks (e.g., Bledisloe park, parts of Te Araroa walkway, and the Manawatu Gorge walks) to avoid a "dog exercise area".

What made you want to give feedback on this consultation?

I walk past Linklater reserve regularly and feel too intimidated by the number of dogs running around off leash in the lower part of the reserve to make use of the walking tracks in the reserve as part of my walk. I would like this to change by having dogs on leash in the lower part of Linklater reserve in a similar way to Victoria Esplanade (a dog on leash area in bush and wetland half of the reserve and a dog exercise area adjacent to this in the upper half of the reserve). This would provide a more equitable recreational and exercise experience for all the residents in Palmerston North to enjoy - not just dog owners!
