#### **Initial Comments:**

We agree with the Government's desire to refocus local councils on delivering essential services and core infrastructure, spending responsibly, and operating under greater scrutiny. However, we also sympathise with the difficulty the council must have faced with the changing laws, and now the tight deadline. Despite the consultation document being presented in a clear format, we still feel there is a great deal of uncertainty, not only in the options, but in the outcomes, and we are sure we are not alone.

# Option 1 The Four, in a Joint Council Owned Organisation (our second choice) – What we like about this option

Assuming the council's assumptions are correct:

- Most affordable
- Close geographically, easy connections
- Communities have strong links
- Scale reduces costs
- Attract and keep skilled staff
- Good staff coverage
- New regulations will ensure quality, monitor cost, strong oversight of CCO

#### Option 1 – What we don't like about this option

#### Other councils' preferred options

PNCC states "At the time of this document being adopted, all councils listed are intending to consult on this option".

However, for Kapiti Option 1(The Four) is their Option 2. They state: "Because of the level of capital investment required – and in particular Palmerston North City Council's 'Nature Calls' wastewater treatment plant project – this option requires a higher level of debt in the short to medium-term. This in turn requires a higher level of revenue to meet the necessary funding ratios"

For Manawatu Option 1 (The Four) is their Option 3. They state "The water service charge would peak at almost \$850 more than the status quo in year eight of the Water Services Council Controlled Organisation. This dramatic increase is largely due to considerable capital projects required by Palmerston North City Council. In a joint model, Manawatū District Council would be subsidising these projects throughout the 30 year period that was modeled. At the end of this period, the household charge for a connected property in the Manawatū District would still be higher than the status quo"

For Horowhenua, Option 1 (The Four) is their Option 1. However, if only Horowhenua decides to go with The Four, it is no longer a good option for Palmerston North and the pros listed above wouldn't not be so great, if any.

At this stage, it is unknown which way other councils will go. However, we believe residents generally would trust the assumptions presented to them by those who have had more time to investigate, look at reports etc. It is overwhelming for the regular resident. So, with only 1 of the other 3 proposing our Option 1 as their Option 1, how likely is it that this option will survive?

#### Lack of opportunities for community to be involved in decision-making

Another reason for not liking Option 1 is that, as the council states "There is unlikely to be opportunities for the community to be involved in decision making. There could be consultations from time to time. The community would need to advocate for services if they had concerns." Currently, we have been in discussions with council regarding the proposed Milson Line bore. Full disclosure, the project is proposed over our fence, so we have a vested interest. However, our main concern is that, if the bore is sunk on Airport land, it could be a serious public health risk. The letter initially sent to the council is attached to this submission as Appendix 1. What happens to this consultation, and others, if there is less opportunity for the community to be involved in decision making?

#### Better borrowing opportunities not necessarily a pro

The council states: "The new legislation allows new water organisations to borrow more money to fund infrastructure projects than what councils can now. Currently we can borrow 2.8 times our revenue (or up to 280% debt to revenue ratio). Our council has chosen a lower limit of 250%.

Water organisations will be able to borrow up to five times its revenue (up to 500% debt to revenue ratio) for water construction projects." So in this statement, the council has indicated that maximising borrowing isn't prudent, choosing 250% instead of the possible 280%.

#### Less say in joint organisations

Council states: "A bigger population doesn't mean a bigger say in joint organisations". Although Palmerston North has the bigger population, it does not mean our projects take preference. What would be shelved?

#### Will water services improve, or are we just hoping they will

Council seems to have some doubt "We believe your water services <u>could</u> improve. Scale isn't everything. In fact, it can produce problems. We were reminded recently of the problems Wellington faced with Twin Lakes reservoir.

Uncertainty in organisation structure, charges etc

# Option 2 The up to Six, in a Joint Council Owned Organisation(our third choice)— What we like and don't like about this option

Basically similar comments, although "The up to six" option would be even worse.

#### Option 3 Status Quo with Changes (our first choice) - What we like about this option

#### Status Quo is working!

Council states "We've looked after our city's water needs. We're proud to have taken good care of Palmy's water, meaning you have safe and resilient water infrastructure". So we are not sure why there is no enthusiasm to continue as such.

#### Kapiti and Manawatu think this option is financially viable for them, why not us?

We note that the council states that this option, Status Quo with Changes, is not financially sustainable and therefore not legally compliant. However, from the information provided, we are unable to see why this is not financially viable.

Both Kapiti and Manawatu are proposing this as their Option 1, and we cannot see where Palmerston North differs. Is the Nature Calls \$4m+ the reason why a CCO is attractive?

#### Borrowing may not be an issue

Council have put forward an argument that borrowing would be at a higher debt to revenue ration with a joint organisation. However, in Kapiti's consultation document, they mention that "It's noted the Board of the Local Government Funding Agency (LGFA) has discretion to approve bespoke debt limits for high growth councils (which includes Kāpiti) up to a maximum of 350% of revenue. This offers a potential pathway to access further debt funding if we need it in the future." Why can't Palmerston North access this?

#### Option 3 (our first choice) – What we don't like about this option

Obviously, if we become convinced that this Option 3 is not financially sustainable and therefore not legally compliant, we should not pursue it.

# Serious Public Health and Financial Risk with Proposed Site of City North Ground Water Bore

Please take this matter seriously. I am a retired ex government Research Scientist qualified in Geology, Geochemistry and Geophysics.

#### Meeting with PNCC to discuss new water bore

On 15 July 2024, Tunmbi Tokode and Wayne Ventor from Palmerston North Water Team and Perene Green from Property Team attended a neighbours meeting at my home to address us about their new water bore and treatment plan. Three proposals were presented, but all with the actual bore sited on Airport land bordering properties 22, 16 and 14 Flygers Line, at Test Point 252.

#### Information lacked any mention of known PFOS/PFOA contamination

Although we followed up the meeting with a letter giving reluctant agreement to one of the three proposals, we later realised that a major risk was never flagged by the council, either verbally or in any documentation we were given. This is the potential risk of PFOS/PFOA (the "forever" chemicals) in any bore water on or near Airport land, produced by the use of firefighting surfactants containing this banned chemical by the Airport for many decades (possibly since the 1950s) up to December 2017.

When I started to research this, I found a mass of articles relating to this contamination although I do not have access to the official reports, which I presume the council has. These chemicals are called "forever" chemicals because they persist for centuries in nature and the human body, and health effects include increased risk of some cancers, impaired immunity and delayed children's development. This is a worldwide problem near Airports and the Ministry of Environment and other government agencies have been actively investigating these chemicals.

#### Council advised residents of risk in 2018

In 2018, after high levels of the PFOS chemicals were found in surface water samples, Palmerston North residents were advised not to gather eels or water cress at Mangaone Stream, Richardsons Line Drain or streams near the Airport. And for those with private bores to contact authorities.

#### Risk still remains and could increase

Council will be aware of the water situation at Ohakea. Even though a surface clean up was undertaken, the chemical has percolated outwards and downwards, creating a 'plume' reaching a kilometre from the base and into the groundwater below the surface, accessible by water bore. Reports have shown that the plume could persist and spread for more than 100 years. A recent RNZ

article reported that the chemicals are persisting in the Ohakea area, and some levels are rising. To avoid any future problems for Ohakea, a new bore has been built, 10 km away from the origin of the chemical pollution. The situation with land in and around Palmerston North Airport would be no different, as Airport firefighting procedures were common throughout New Zealand for many decades.

From our location at 22 Flygers Line, we regularly, for several years, watch the Airport Firefighters drive to the west end of the runway near Milson Line in their machine and spray the area around, as both practice and presumably testing their equipment. I know they are doing this safely but possibly for more than 60 years this was done using the fire retardant foams containing PFOS compounds. The proof that these chemicals have entered the ground water is in the water sample tests showing streams around the Palmerston North Airport are contaminated with PFOS chemicals, some results between 3 and 12 times the safe drinking water guidelines.

#### Risk is Deep Groundwater Contamination, not Surface Contamination

However, this surface and near surface contamination is not the issue I want you to look at. It is the deep groundwater spread of the POFS. Even if a water test at the proposed bore site showed levels that may at present be safe, there is proof that these PFOS contaminants will spread outwards and downwards in future, for 100 or more years and reach the bore. The high volume of water taken from the new bore will increase the spread of the PFOS water downwards and outwards.

#### Reconsider and avoid a major public health and financial risk

Ohakea is a good example of what to expect, and the council should heed this warning. My concern is that, with all the information the Council is aware of regarding these chemicals, their use over many decades and their extent, to spend several million dollars putting in a new bore within the danger zone is reckless, and should the bore become contaminated in the near future, the council is leaving itself open to an extensive legal class action from the public of Palmerston North, on health grounds. None of us would wish this to happen.

This is a major risk and, combined with the concerns regarding flooding listed in our letter of 18 July 2024 to Mr Tokode, leads us to believe that an alternative site should be chosen well away from Airport land.

Please instruct your Water Team to locate their new water bore <u>well away from the Airport land</u>, and not on the Airport land as they are currently planning to do. The future health and financial risks are too great for the council to take. I do not think agencies such as the Ministry of Environment would approve of a bore near Airport land, as they have studied PFOS and PFOA for some years.

I look forward to a speedy reply to my concerns. At this stage, I have only flagged the risk to the council and close neighbours, but am prepared to take further advice if we do not receive a satisfactory reply from you, because I feel this is a major concern. I do not wish this to be a confrontational issue as all my previous dealings with the Palmerston North City Council have been very reasonable and fair and I therefore hope you will not take this letter in any way as a form of criticism but as a genuine concern of a serious risk to the council.
