If we must share our water management, I like that water management would be shared between only the nearby councils, with which we have closer associations, and a greater sense of what the challenges are for this region. A smaller number of councils would allow our council/representatives to have more of a say in decision making, and hopefully more agreement on issues, and hopefully more community consultation. The cost efficiencies are attractive.

Please tell us what you don't like about this option

As a council, Palmerston North has always managed its water services well - from supplying top quality drinking water to residents, to wastewater management, and flood protection. With wise council decision making, coupled with timely community consultation on key water infrastructure and issues, over time our council have invested wisely in things that matter, including good investment in our water. Our community has a real sense of pride in our water and how it has been managed. It was only a few years ago that Palmerston North water won best tasting water at a national competition where regional water was blind tasted. We have the highest quality service for water that I, and I believe our community is proud of.

My concern is that we lose our ability to manage and make decisions about our own water, or our ability to decide is diluted by input with other councils with their own concerns about their regions water. Our community would lose its own sense of pride in our water management, that has been done so well in previous years. While there are cost benefits, we lose control of our water services, what water investments are made, and there is less public consultation, so our community would have less of a voice in water infrastructure and issues. Also, our PN ratepayer contributions would not necessarily go into improving our own water infrastructure, as the other regions may not have as good water infrastructure and quality as we do already. Also, are there hidden costs of providing water service to a greater geographical area, with greater infrastructure costs, despite the larger population base for funding?

Please tell us what you like about this option

I do not like this option at all. I do not see any benefits.

My concern is that PN council, and hence the PN community, lose our ability to manage and make decisions about our own water, or our ability to decide is diluted by input with other councils with their own concerns about their regions water. As discussed earlier, our community would lose its own sense of pride in our water management, that has been done so well in previous years. The wider communities have no relationship with each other, and hence I think decision making would be impaired. We lose even more control of our water services, what water investments are made, and there is less public consultation, so our PN community would have even less of a voice in water infrastructure and issues. Also, I definitely think there would be greater costs of providing water services to a greater geographical area, with greater infrastructure costs, and greater time spent debating priorities across different regions, despite the larger population base for funding. Also, our PN ratepayer contributions would not necessarily go into improving our own water infrastructure, as the other regions may not have as good water infrastructure and quality was we do already. And the financial projections show that this option is more expensive than Option 1.

Option 3

Please tell us what you like about this option

I like that our water would continue to be managed by our own PN Council. We would be able to continue to assess and invest in water infrastructure to benefit our community, as we know what the challenges and priorities are for this region. Our council and community would continue working together as we have done in the past, with good decision making and community and iwi involvement.

As a council, Palmerston North has always managed its water services well - from supplying top quality drinking water to residents, to wastewater management, and flood protection. With wise council decision making, coupled with timely community consultation on key water infrastructure and issues, over time our council have invested wisely in things that matter to our city, including good investment in our water. Our community has a real sense of pride in our water and how it has been managed. It was only a few years ago that Palmerston North water won the best tasting water at a national competition where regional water was blind tasted. We have the highest quality service for water that I, and I believe our community is proud of. Maintaining management and control as per the status quo, would allow our water services to continue to be managed well.

While this option would cost ratepayers more, I would be happy to pay more, as we would know that the money we are paying would go directly into improving our water quality for our Palmerston North community, rather than being spent elsewhere on other regions (which may not have as good a starting water infrastructure and quality as we do).

Please tell us what you don't like about this option

The issues with this option are the higher cost and legal compliance. I am unsure why the government has changed legislation, making it more difficult for councils to manage their own water, when PN council has always managed its own water well, delivering an excellent water service, while also balancing spending and priorities in other areas of the council infrastructure and services. However, given the challenges that I see with managing the issues with the other options proposed, I would rather pay the extra money as a rate payer towards our own water infrastructure and services, to see the benefit of this investment in our own community, than lose control over our water, and have no input into the way that our money is spent on water infrastructure and on where that money is spent (i.e. spending in other regions instead of into our own community).

Which councils would you like to see Palmerston North work with for future water services?

I think that we should not work with any other council for management of our water, for the reasons I discussed earlier. If we must work with other councils, then we should work with the smallest number of councils possible, and keep these only to those councils immediately alongside Palmerston North geographically, as we already have relationships, and a shared community, and shared challenges, and ratepayers money invested would directly go into investing into our own region. Ideally, we would only share our PN water management with the neighbouring townships/region i.e. only Feilding and Ashhurst.

Please share any other feedback you have about water service delivery in the future

I would like to see our PN community continue to have pride in our water management, services, and infrastructure, and still feel connected and responsible for this.

I would also like to ask what review/feedback system is in place to collect views from the community post the decision and implementation of the water management system. I think continuous public consultation is very important, and the community should still have a say in our water management, and this links strongly with the community maintaining a sense of responsibility and pride in our water management.

Thank you for giving us the opportunity to have our say. It is disappointing that these reforms are being rushed. I am aware that this is out of the council's control, but it reminds me of Three Waters and how rushed that was.

Reforms like this take time. This will shape our communities for decades, yet we were given around a month to have our say.

After going through the different options provided by PNCC and the other councils, it's clear they all have different opinions or options.

Only Horowhenua and Palmerston North have 'the four' as their preferred option, while Kapiti and Manawatu would prefer to keep the status quo, which I understand. However, the Manawatu Council has also given their residents the option of 'the two', which is MDC and PNCC having a joint organisation.

I am split between the 'two' and 'four'. Palmerston North and Manawatu councils both border each other, and their residents use both districts for work and recreation; after all, some areas of the PNCC were once under the MDC.

On the other hand, it's good to see our council fostering relations with Kapiti. This option gives us a bigger area to work with, which has some pros and cons.

With water assets, you need to look after our rural communities. While many may have tanks or use less water because of a smaller population, these communities are the backbone of New Zealand and deserve the same investment.

In Bunnythorpe, brown water is common because our water assets were never maintained well, and they're no longer fit for purpose.

As I said before, with option four it gives us a bigger area, which means more places will need their assets replaced. So, we need to ensure that all assets are replaced fairly and not focus on one town each time there is a project.

With this larger area, we run into travel time. While it may only be 1.5 hours between the councils, that is still a long way for someone to travel to fix a burst pipe in Feilding if they have to come from Paraparaumu, compared to Palmerston North to Feilding, which is anywhere between 15-25 minutes. So this organisation will need to ensure they have enough staff to repair faults quickly so our people don't have to wait for an hour for someone to respond.

The entire lower North Island is in the firing line for earthquakes and tsunamis, but as we all know, the risk is higher in Wellington. Kapiti DC has a higher population closer to the coast compared to Horowhenua and Manawatu, so we must factor this in because if a big quake strikes, all four councils will need to fix assets in their own area, but Kapiti

could face a higher bill compared to just Manawatu and Palmerston North, which would be a smaller area and closer together, so repairs could be cheaper and done faster.

I get the importance of the water organisation being independent of the councils, but what happens if the organisation's leadership starts making bad decisions or things aren't looking good? Elected members and the public need a way to ensure the board stays in check and to take action if it's needed.

One way this can be done is through proactive releases of information, official information requests, and community consultation.

While councils may try to honour iwi involvement, I think it's important to remember that all ratepayers should have just as an important voice, and all people, regardless of who they are or where they come from, should have equal and fair access to safe, clean, and sustainable water.
