SUBJECT CORRECTIVE ACTION OF GRANTING AN EASEMENT TO POWERCO

AT VAUTIER PARK, PALMERSTON NORTH

Corrective Action

This memorandum is to notify the Executive Leadership Team of the corrective action to be carry out as follows:

To grant an easement to Powerco Limited ("Powerco") at Vautier Park, Palmerston North for formalising the existing line that has been there for supplying power to Freyberg Community Pool and Freyberg High School and for any future electrical works required for the area.

Background

The existing power line supplying electricity to Freyberg Pool and School, owned by Powerco, is sitting on council's property, i.e. along the drive way from Tremaine Avenue into Vautier Park, but there is no easement registered.

The council has asked Powerco to carry out further electrical works by taking a feed of the existing line to supply Vautier Park Netball Courts, Puriri Terrace, Palmerston North. This work is new complete resolving the problem of the insufficient power to the courts to run the training lights. The further electrical works has prompted Powerco's request to register the easement which should have been done at the first place.

Powerco's easement requirement will be for the power cable up the driveway from Tremaine Avenue to the Ring Main Unit that are sitting on the land being part of a reserve at Vautier Park. Public notification is required under the Reserve Act for granting an easement. The detail easement plan is attached.
