RECOMMENDATION FOR PUBLIC RELEASE

The report and decisions, as outlined below, can be released to the public after applicants and the Board have been advised of the outcome.

RECOMMENDATIONS TO COUNCIL

- 1. That Council appoint Russell Harris as trustee on the Globe Theatre Trust Board for a period of up to three years.
- 2. That Council appoint Sarah Everton as director on the Palmerston North Airport Ltd Board for a period of up to three years, subject to the appropriate checks.
- 3. That the report and decision be released to the public following notification of appointments to the individuals and boards.

1. ISSUE

An appointment process has been undertaken to seek one trustee for the Globe Theatre Trust Board, following the retirement of long-serving board member Margaret May; and one director for the Palmerston North Airport Limited (PNAL) Board, following notification in May that Gerard Gillespie would not be seeking reappointment at the conclusion of his term in June 2023.

A role on the Palmerston North Performing Arts Trust role was also advertised. We were unable to fill this role at this time.

The selection of the preferred candidates was undertaken following the completion of the appointment process in accordance with the Appointment of Directors and Trustees Policy 2022 ('Appointments Policy').

The appointment panel comprised of the Mayor (Grant C Smith), Councillor Vaughan Dennison, Councillor Leonie Hapeta, Chief Executive (Waid Crockett), and the Board Member Shelley Mitchell-Jenkins, in the case of the Palmerston North Airport Limited position.

The appointment panel comprised of the Mayor (Grant C Smith), Councillor Vaughan Dennison, Councillor Rachel Bowen and the Chief Executive (Waid Crockett), in the case of Globe Theatre Trust Board position.

Recommended applicants' resumes are attached.

It should be noted that Russell Harris applied for reappointment for a further term.

17 applications were received and shortlisted. 2 interviews were held for the Globe role and a further 4 for the Airport.

2. NEXT STEPS

In the event Council adopts the appointment recommendations set out above, a police check will be undertaken for Sarah Everton, according to the Appointments Policy. Reference checks have already been completed.

Following this, the appointed and unsuccessful applicants will be advised of the outcome of their application. The Boards will then be advised of the successful appointee and the appointment made public.
