- 1.2 And the retirement by rotation of: Te Manawa Museums Trust – Mr John Fowke and Mr Tyson Schmidt Globe Theatre Trust – Mr Gerard Hudson and Mr Russell Harris Regent Theatre Trust – Ms Susan McConachy Caccia Birch Trust – Ms Patricia Keiller Palmerston North Airport Limited – Mr Gerard Gillespie and Mr Jon Nichols Palmerston North Performing Arts Trust – Ms Sheridan Hickey and Ms Margaret May
- 1.3 If Council decides to advertise all positions, we have the following number of vacancies:

Te Manawa Museums Trust – two positions Globe Theatre Trust – two positions Regent Theatre Trust – two positions Caccia Birch Trust – three positions Palmerston North Airport Limited – two positions Palmerston North Performing Arts Trust – two positions

# 2. BACKGROUND

2.1 Letters from Te Manawa Museums Trust Board, Regent Theatre Trust Board, Globe Theatre Trust Board, Caccia Birch Trust Board, the Palmerston North Airport Limited



and Palmerston North Performing Arts Trust have been received by Council advising that their respective Board Members are due to retire by rotation, and outlining the retiring members availability for re-appointment (if any) (see attachments).

- 2.2 It is worth noting that Caccia Birch Trust are currently operating outside of their Trust Deed with only three current Trustees. The Board has therefore requested that Patricia Keiller be reappointed to maintain stability of operations.
- 2.3 Similarly, Regent Theatre Trust would be operating outside their Trust Deed if a replacement trustee were not successfully appointed. Due to the considerable disruption associated with COVID-19 and the other retiring Board member not seeking reappointment, the Board has requested that Susan McConachy be reappointed.
- 2.4 Council Organisations are requested to advise the Council as soon as possible, but not later than three months prior to the date of expiry of a trustee or director's term. Such advice should include the details of the directors who are due to retire and whether or not they wish to be considered for reappointment. The Council is entitled to appoint up to five members on the Te Manawa Museums Trust Board, six members on the Regent Theatre Trust Board, five members on the Globe Theatre Trust Board, six members on the Caccia Birch Trust Board, five members on the Palmerston North Airport Limited Board and two members on the Palmerston North Performing Arts Trust Board.
- 2.5 In appointing directors/trustees, the Council will be seeking persons with relevant skills and ability to make a significant contribution to the successful operation of the organisation concerned.

# 3. NEXT STEPS

- 3.1 Respective Trust Boards will be informed of reappointments and/ or new appointments.
- 3.2 If Council decides to advertise the positions, an appointment process will be set out as per the 'Appointment of Directors and Trustees' policy. The Appointment Panel will comprise of:
  - The Mayor and/or Deputy Mayor
  - Chair of the Finance and Audit Committee
  - Chair of the Arts, Culture & Heritage Committee
  - The Chief Executive (or their representative)

Re Appointment of Ordinary Trustees to Caccia Birch Trust Board (Inc).

Dear Natalya,

The Caccia Birch Trust Board currently has a membership of three Council Appointed Trustees who are deemed to be Ordinary Trustees in accordance with the Trust Deed and two Board appointed Trustees appointed by the Trust Board at the Board's Annual General Meeting in Sept 2019. One, Jireeth Soni, has advised his intention to resign before the next AGM.

The following sections of the Constitution are included to assist Council with the process of appointment of Trustees to the Caccia Birch Trust Board as Trustee membership must be in accordance with the Constitution.

Section 5 (5.1) of the Trust Deed states that the Board shall consist of not less than five (5) or no more than six (6) Ordinary Trustees and not more than two (2) Trustees co-opted in accordance with rule 5.4 with the maximum number of Trustees being eight (8)

Section 5.2 Ordinary Trustees are appointed for a period of three (3) years however at the expiry of that term shall be eligible for reappointment.

Section 5.5 addresses the rotation of Trustees with at least one third of the Ordinary Trustees retiring at each Annual General Meeting. Any retiring Trustee shall hold office until such time as a replacement person is appointed unless the Trustee otherwise requires. This requirement will be met by the resignations of Messrs McKenzie and Soni

It has become the practice of this Board to suggest to Council individuals who are available to fill vacant positions, as advertising for Trustees to the Caccia Birch Trust Board has proven unsuccessful. The present Trustees currently constitute a skill-based Board, and therefore vacancies on the Board need to be carefully selected.
