#### 1. ISSUE

Civic Honour Awards are Council's mechanism for recognising outstanding voluntary service in the community.



#### 2. BACKGROUND

Council for the previous 30 years has sought nominations from the community for individuals deserving of recognition through a Civic Honour Award for voluntary service. A selection panel has been appointed and thirteen nominations were received and considered by the Selection Panel. Note that one nomination was void and rescinded due to the nominee being in paid employment for the services nominated for.

After consideration of the nominations, the Selection Panel has recommended that Council grant awards to:

#### Steve Stannard – Sports

Nominated for providing voluntary services to cycling advocacy and events such as UCI International Gravel and Tarrace and community cycling in the City.

#### Stewart Harrex - Environment

Nominated for being an exemplary environmental advocate in the City for more than a decade as part of the Environment Network Manawatū Management Committee, including the role as Co-Chairperson.

#### Roy Tankersley – Arts & Culture (Music)

Nominated for his contribution to music locally, regionally and nationally as well as convening the Manawatū Organ Group. Roy also supports Saturday morning music classes for children, is a member of the Earle Creativity & Development Trust and member/performer with Musica Viva Manawatū, Royal School of Church Music and Choir Master for many Presbyterian parishes, to name a few.

### Jillian Spicer - Community/Social Sector

Nominated for being a volunteer in Palmerston North for 41 years working with refugees and is the organiser for the Red Cross Annual Book sale.

## Maryanne Mechen - Arts & Culture (Dance)

Nominated for services to Dance and the Performing Arts. President of the progressive Palmerston North Dance Association and active Board member of the Performing Arts Competitions Association of New Zealand (PACANZ).
