RECOMMENDATION(S) TO COUNCIL

1. That the report be received and Council give direction as to the next steps.

1. ISSUE

The rates remission application by The Ozanam House Trust was declined by the Rates Remission Panel on the grounds that it did not meet the "Remissions for Community, Sporting and Other Non Profit Organisations" policy objectives.

2. BACKGROUND

Any requests for a rate remission are first considered under the 1st Schedule of the Rating Act to see if it is one that is mandatory.

If it does not meet the conditions of the 1st Schedule, then it is referred to the Rates Remission Panel which was established by Council in 2015. The panel consists of the Chair/Dep Chair Community Development, a staff member from Community Development and Finance.

The panel considers the request against the Rates Remission Policy, which the Council published as part of its 2018/28 10 Year Plan.

The relevant section of the Policy that this application was considered under is "Remissions for Community, Sporting and Other Non Profit Organisations" The following is the objective of the policy:

2.1 Objective

To facilitate the ongoing provision of non-commercial community services and noncommercial recreational opportunities for the residents of Palmerston North City.

The purpose of granting rates remission to an organisation is to:

• assist the organisation's survival

• make membership of the organisation more accessible to the general public, particularly disadvantaged groups. These include children, youth, young families, aged people, and economically disadvantaged people.

2.2 Conditions and Criteria

This part of the policy will apply to land used by a charitable, sports or recreation organisation, which is used exclusively or principally for sporting, recreation, or community purposes.

The panel in declining the application did recognise that this would be unexpected and agreed to spread transition to full general rates over 4 years. The total general rate remission which the application was seeking is \$24,472. For 2019/20 the effect on the Trust is going to be \$6,118.

If the Council wishes to expand the objectives of the Rates Remission Policy to embrace organisations like the Trust, then this can only be done through the public consultative process. The easiest way at this time of the year would be via the 2020/21 Annual Plan process with effect 1 July 2020.

If the Council, for this year, wishes to place the Trust in its expected position then it could make a grant to the Trust of \$6,118 (Gst incl).
